### AN OUTLOOK ON LEBANON by L.N. Bakalian

It is September, and Maria and I are still in Lancaster, not in Beirut as we though last Spring. The stage has been set and reset, torn down and rearranged many times since then, and as Lebanon has fared, so have our hopes. We spent the entire summer watching and waiting, and still we are waiting to know what our decision will be. It might be helpful for me to relate to you the situation there as I see it - not as a Middle East expert, which I am not, but as an interested observer, as one who has a stake in what is happening there.

The Lebanese themselves show a fair amount of foolishness on one hand, and powerlessness on the other. They have fancied themselves as a tolerant and peace loving nations for years, as evidenced in their governmental set-up. The president is to be a Marenite Christian, the Prime-Minister a Sunni Moslem, and so forth, representing the different religios groups. This was based on the majorities in the country at one time, but it is now held to by the Christians rather tenaciously, because they are no longer in the majority. The last census, taken in 1934, does not show the Moslen population as it really is. So the social fabric has been strained for years, and the interrecine strife there existed before the Lebanese decided to grandly take in the Palestimians, who were kicked out of Jordan in the early 1970's. With such disunity, they were an easy pushover for the Palestidians who knew what they wanted: to be in a good position to get at Israel. So as discontent grew against the Palestinians, who overran the land and made Lebanon their own little battleground, armies of Lebanese began to surface and unite against common enemies: foreign armies.

The Syrians have been in Lebanon since the 1975-76 civil wars, at the "request" of the Lebanese government. Actually, the Arab nations decided it would be a good idea for Syria to be there, and she jumped at the chance to take over Lebanon, which Syria considered part of herself anyway. ber that since Lebanon's independence

in the 40's, Syria has never opened diplomatic relations with Lebanon, a further indication of her disbelief in Lebanon's severeignty. Syria is much like the Palestinians: they act like they own the place. They have their checkpoint and their curfews and their taxes. If you want to build somewhere and you get a permit from the Lebanese government, depending on where you are, the Syrians or Palestinians would tell you that you could not build, unless you also got a permit from them. Lebanese just get angrier and angrier, while feeling less and less able to do anything about it.

The armies which have arisen since the occupation of Lebanon by these foreign troops are numerous. The major ones are Saad Haddad's in the south and the late Bashir Gemayel's in central Lebanon. There are other "Christian" armies besides these, as well as Moselm armies at different points on the political spectrum. Some hate the Syrians, but support the Palestinians. Some the other way around. Some hate both. Some hate the Christians more. hate the Christians less, and are willing to collaborate against common enemies, the permutations go on and on. But one thing should be made clear: these are not "religious armies," fighting "for the faith." Those are labels tacked on by people in the West who can think of things in no other terms except black and white. The other night I heard a TV preacher spouting some of the most inane ignorance I have ever heard about how terrible that "Christians" are being killed in Lebanon, as if the Christians themselves did no killing.

Isreal is presently seen as the bad guy, especially now that the Israelis have reasserted themselves in Beirut, at no one's request, following the assassination of President-elect Bashir Gemayel. The people of the Middle East have never particulary trusted the Israelis, though the West is just beginning to understand why. Not the least of those who mistrust Israel is Lebanon. Their welcoming the Israelis in to get rid of the Palestinians and others was not out of the affection for Israel, but because they knew Israel

AN OUTLOOK ON LEBANON (cont.) could do the job. Israel was to them like a paid assassin. Get in, do your work, and get out. Your payment is more secure borders (though Israel has and will undoubtedly take more). The world stood aside and let Israel go to the work, though an occasional bleat of protest was heard. The world knew that something had to be done with the Palestinians, and they thought that maybe this was it. Lebanon was at the point of desperation, but until the Israelis got involved, nobody really cared. The Israelis have get blood on their hands, it's true, but they are not the only ones. The many sides involved all share blame.

Lest we get too comfortable, the U.S. also carries its share of responsibility. Until we were implicated as accessories to certain crimes, we didn't much care wat was happening. But now that the U.S.'s pristine sanctity has been called into question, we say "No, no Israel. You mustn't do that with our guns." We fuel the controversies in the Middle East, as do many other nations, then get upset when the arms are actually used. Added to this naivete are the impotent cries from different leaders, including church heads, saying, "Stop the war!" as if they were God. Who needs God when we've got Menachem Begin? The only sense that has come out are actions: the recruitment of doctors and nurses to go to Beirut (through Church World Service), the money for food and shelter which is being distributed, the commitment of our military troops there. Words have lost their meaning. Action has the only currency. I hope that the U.S. will take the lead in not worrying about its own blemishes, but act on the needs that are apparent there, putting its treasure where it says its heart is.

## TWO CRISES OF CONSCIENCE by Tom Shelley

This summer was an eventful one for 20 year old Enter Eller of Harrisonburg, Virginia. On August 17, he became the first young man to be found guilty on federal felony charges of failing to register for the draft. His reason for not registering was direct: "I do not have hatred for authority. I have not registered simply because the U.S. Government has asked me to do something God would not have me do." For following his religious convictions he faces up to five years in federal prison.

This summer was an eventful one for Bob Jones University. A tuition tax credit bill was finally introduced in Congress which would greatly aid the privately supported institution. But amendments were attached that would require the IRS to deny recognition to institutions whose racial policies were contrary to the 1964 Civil Rights Act. Once again, Bob Jones stands to lose for standing by its conviction that interracial marriage — and hence interracial dating — is unbiblical and sinful.

What do these two cases have in common? They both show the consequences of holding an unpopular religious belief. And they both show the fences thrown around the religious freedom of the First Amendment: "Congress shall make no law reespecting an establishment of religion, or prohibiting the free exercise thereof."

The American constitutional tradition has been and continues to be one of limiting religious liberty to those things which are "churchy," overtly pious, and otherworldly. But when religion comes out of the cathedral and enters daily life, particulary as a guide for conscience and morality, and becomes a central factor of one's attitudes and actions, it no longer enjoys Constitutional protection. One's public actions are considered to be subject to public policy, regardless of whether their motivations be religious.

Hence, "the free exercise thereof" is viewed extremely narrowly. It does not apply to practices — such as Bob Jone's ban on interracial dating — that

are somehow out of step with society's standards. Nor can it be raised as a defense for disobeying a law — such as Enten Eller's refusal to register — that is out of step with one's religious belief.

Regardless of our opinions and emotions regarding the morality or acceptability of Enten Eller's or Bob Jones' actions, we should be supportive of both as they attempt to assert that faith is relevant to all of life, and that the government has no right to judge the legaility of one's religious practices. Religion -- true religion, as defined by the Hebrew prophets —cannot be isolated only into worship, but must be carried out in daily life. This is a point which time and again the American government refuses to recognize, despite the explicit working of the constitution. The Bible and the Federal Government are on a collision course. Government cannot be allowed to regulate religious practices - no matter how bigoted, prejudiced, unlawful. For where will regulation end? Bob Jones has been punished for believing interracial dating is wrong. Shall Catholic Bishops be tried for treason for preaching against American Foreign and military policy in Latin America? Enten Eller has been prosecuted for breaking the law requiring draft registration. Shall liturgical churches be prosecuted for administering communion wine to underage believers? Just how far can government go in punishing practice or dictating doctrine?

A answer might be had from history.
During the Council of Nicea, it is believed that the Roman Emperor Constantine resolved the Christological debate by urging the pope to choose homoousia—"of one being with the Father" as the creedal formulation of the Divinity of Christ. What happened then might happen today. Who will be the modern day emporor to impose creed, faith, or morals, upon the Church? Let us keep Government out of the worship place.

A DISCLAIMER: While I admire and ardently support Bob Jones' efforts to be free of IRS harassment, I am equally adament in my opposition to the distorted doctrine the institution holds that caused this conflict. Yet right or wrong, no religious principle or practice should be subject to government persecution.
