THE OBLIGATION OF THE UNITED ... CHURCH OF CHRIST TO ITS THEO-LOCICAL STUDENTS

There is no question that the relationship between our church and its theological students is one of mutual obligation. In this very brief column. I would like to mention three aspects of the church's obligation to the students.

The first obligation involves the student's call bothe ministry. This call is from God through the church. From the time of the New Testament, the Holy Spirit has guided the church in calling out from its number those who show particular promise for the work of the ordained ministry. The "under care of synod" status is our church's way of affirming and maintaining this call.

The second obligation is to train-those who have been or are being called to the ordained ministry. We believe this to be a crucial function of the church. It is for this reason that our Seminary has always been regarded a privâte institution to which the delegated.

THE WORSHIPING COMMUNITY

We hear much discussion concerning the Seminary community, the fellowship within it, and the worship by it. Many of us who have been here for more than one year have come to think of the Seminary as the center of our spiritual development. We attend more services of worship in the Chapel than any other place, we commune here most frequently, and we enjoy perhans a closer fellowship with our friends here than we have before experienced. share with each other the difficulties we ourselves find in our faith, and, when we are man enough to do so, we share knowledge of our own personal shortcomings with one another. Yet, while we may be a worshiping community, we are not, at the same time, a Church. We do not baptize children as we are not a congregation capable of accepting responsibility for the spiritual growth of those children. Rother, so are representatives of various settiesed congregations and while we may together share our faith in a more unique way than previously experienced, we nevertheless maintain membership in our home churches. It is there that primary responsibility of community worship remains.

How does this bear on the subject of the worship life of the Seminary community? It most certainly does not absolve us from any worship experiences while we are separated from the congregations to which we belong. It does however, throw the initiative for a devoloping and growing life of communion with our Lord upon the individual, rather than upon the Seminary as a whole. While the Seminary may provide the facilities of worship, it is in no way responsible to see that the individual students and their fami-

Exactly where does the seminer ary student stand within the United Church of Christ?

At the present time, his status is roughly the same as that of the college student. He is recognized. as a student for the ministry and as one under the care of a particular synod within the denomination. His fitness and limitations are defined in the by-laws of the denomination's constitution. His life and course of study at the seminary he attends is predetermined. He is tested and retested in regard to his intellectual He is examined accomplishment. and re-examined in regard to his personal beliefs. If the student successfully completes his seven years of education, if he demonstrates his fitness before an examining board, if he proves to the satisfaction of everyone that he is worthy coming aminister, then, and only then, he is ordained. After ordination the fermer theolegical student is a full-fledged winister of his United Church of Christ. He den now perfect the mites and secrements of the Chapth. he can now enter into fellowship with other ordained persons, with his ordination he has gained status-he has arrived.

However, seminary students seem more naturally concerned with the here and now rather than what seems to be an event in the far future. This brings us back to the original question: Where does the seminary student stand now?

The seminary student is supposedly "under the care of his

which the student receives varies
from one synod to the next. In
some synods, the theological student is merely a name on a list,

ment and supervision to the student. The function is fulfilled both by the synodical committees on church and ministry and by the Seminary faculty. Finally, the church seeks to meet this obligation to sustain by financially undergirding the student during his time of preparation.

Since this article was requested in part to clarify this final statement, I would like to provide a few details. The Church makes some of this support available through the Seminary itself. For example, the educational cost (cost exclusive of room and beard expenses) for each student in the Seminary for this year is \$2,203. Of this amount, the General Synod provides \$1,024; the endowment funds which have been contributed by church people through the years pay \$462; the current gifts of church members defray \$345; other income of the Seminary pays \$307, and the student pays \$65 or if non-resident \$95. This means that the church provides 97.1% of the educational expenses for the student.

In addition to this, a number of students receive synodical aid to assist with their living expenses. No figures are available showing how many student loans were granted to Lancaster students, but in 1960, more than 300 E & R students shared \$99,975 in student loans. These loans are granted on the basis of need. The Council for Church and Ministry assumes that its loan fund should be distributed for necessary and justifiable expenditures only. Since need is determined only according to a schedule of income and need suomitted by the student, there are undoubtedly some inequities. Such inequities may be appealed to the

Those of us who are students here at Lancaster Theological Seminary find ourselves in a rather unique situation as far as status is concerned. As we ask ourselves what our status is, we find it rather difficult to decide. Some students here at the Seminary seem to think our status is lower than it should be.

Cur society has come to be regarded as a society of status seekers. I think it is very important for us as students of the ministry to remind ourselves not to fall into the same pattern. We must remember not to wish to have people set us upon a pedestal. We must not wish for people to bow down and worship us. We must never attain the "holier than thou" attitude and expect special privileges simply because we are students preparing for the Christian ministry.

There is a feeling among some students that the Church is not giving us enough spiritual aid. They think that the Church is not doing enough for us as student ministers as far as our spiritual needs are concerned.

Instead of asking ourselves the question, "How should the Church give us spiritual aid?" Is it not true that we must find for ourselves those spiritual things? When we accept pastorates we try to help others to find ways of strengthening their spiritual lives. We cannot give spiritual things to them, nor can the Church give them to us. We must find them on our own.

The fact that the first two obligations noted above are accorded so little space should not be taken to reflect a peripheral importance. Actually, as in so many things, they represent the true purpose toward which those items which have consumed so much of our space are only implementations.

The Church should speak with the voice of the prophetic Christ. No concrete proposals should be supported absolutely. Specific measures such as profit-sharing, guaranteed annual wage, etc. are at best temporary measures for the governing of an untransformed society,

The Church claims men's absolute loyalty for her Lord. She can never be merely a co-agency for the betterment of mankind. She is with other agencies only in so far as they are subjected to her, and she to her Lord. His is the only cause the Church supports. She may use men to glorify Jesus Christ, but men may not use the Church to serve minor masters.

FRANCIS WILLIAMSON ON BACH

"The Church, for whose greater glory (Bach) wrote most of his music, whose service he considered his life work, scarcely takes notice of him..." Faced with this statement by Paul Henry Lang, let us consider the significance of Johann Sebastian Bach to the church.

Bach lived in a time of theological controversy (1685-1750). Caught between Pietism and Diactic Rationalism, at great personal cost, he turned to Luther and Biblical theology. caused misunderstanding with superiors, and reduced his musical Pelikan writers: "Bach's fundamental theological orientation was almost completely our of harmony with the basic metaphysical and theological presuppositions of the German Aufklaerung. While the Enlightenment had as its avowed purpose the reduction of the content of Christian faith and doctrine to a certain irreducible minimum of common sense, Bach's understanding of the meaning of human life was rooted in the theological conviction that the minimum of Christian faith was the givenness of revelation in Christ." Bach bore this tension throughout his life. The magnificent cantatas, the Passions were not the product of a cultural here. Instead, they were a witness spoken in a day when the ancient symbols were under fire, and the foundations of the faith were threatened. His example of spiritual and artistic courage faithfulness shines as a beacon to our faltering spirits.

Bach, as composer, "represents the acme of polyphonic grandeur and intricacy.." "among the many explanations...why he must always stand as the greatest of musicians, that of his manysidedness is perhaps the most significant. (McKinney and

the Church. It goes without saying that spiritual preparation for seminary is fundamental. It did not take me long to find out that the seminary is not a simple environment. Many life-long assumptions have been challenged, Some of the deeper problems of religion and of life have been examined more critically than we have ever before excerdenced. It has been said that the purpose of a seminary is to educate strong spiritual leaders who speak from their own experience. This is a hard process. and many pass through it in unhappiness and confusion, in retual. revolt, or assume the cloak of intellectualism." Prayer and Bible study in search for Truth is most helpful here but the Church must also remain faithful in their prayers for the strengthening of the faith of its members. along with helping the student personally is of course necessary. Even more important, the student himself must sometimes search for spiritual aid and it should be available to the student whether in studeny followships and activities; or in members of the faculty who recognize their work as teacher, counseller, and friend; or in ministers who know the need which must be met simply as a result of their own seminery experience.

There are many sources of spiritual ald, some which of course are not functioning at present, but the most important part of the spiritual aid which is available is the student's own motivation. Must I repeat the so frequently used verse of Holy Writ? "Beek, and we shall find."

is the same as right living, love, and faith. When these different acts are intermingled with our right prayers and our "formal" worship, then we can say that the wouship of the seminary is as it ought to be.

THE WORSHIP OF THE SEMINARY

But as the record of the conversation between Jesus and the Samaritan woman indicates, true worship is not determined by the place it takes place ("neither Jerusalem or Gerizim"). True worship becomes a reality when it is offered in spirit and in truth. I believe therefore, that it is for each of us to decide for ourselves whether we are participating in the worship of the seminary in this way.

Another yardstick we can use to measure our personal worship in the seminary is the teaching of St. Paul who seems to say hat worship

not able to attend the Christmas
party, he will not get to know the
synod officials and they will not
get to know him. Thus, in many
cases, there is little or no relationship between the student and
the synod.

Whether some kind of relationship will exist between student and synod seems to depend a great deal upon the particular initiative of the synod president. Some synod presidents have very and close relationships with their perspective ministers. In this case the student feels that his synod really cares about him and wants to help make the transition from student to minister an easier one. In other cases, however, some synod presidents do not take the initiative to be interested in the students. They do not bother to keep the student informed of proceedings within the synod. They do not seek to inspire him or to inquire as to his needs. In short, there may not be any kind of relationship between student and president.

A little more interest in the student's spiritual meds is greatly needed. Synod officials must become less apathetic in their future relations with us "clerical neceptytes," not only to promote better church administration but also to make the student aware that he too is a part of the great and glorious mission of the Church.

However, if one looks at the orphanages of the denomination, a similar situation is seen. The orphans "under the care" of the denomination are also well cared for. After all, the orphan at one of the denomination's institutions certainly has financial support, doesn't he? course, the orphan cannot send a Father's Day card to the Evangelical and Reformed Church. cannot look upon the organization which supports him with the idea that they are doing all this for him alone. It is difficult for him to see himself as more than a name on some list, an occupant of a certain bed or a certain build-He is not certain of where ing. he stands...of where he belongs.

It is not the purpose of this editorial to criticize the "care" given theological students by some synods. However, it is our feeling that something must be done about the system that allows some students to receive a great deal of supervision and moral support from their synods while others are regarded as names on a list. An orficial improvement of the theological students status is definitely in order.

lies develop or maintain their times of worship.

Much has been said in bull sessions and at coffee break about the lack of time, interest, etc., on the part of the Seminary in providing for the spiritual growth of the student. It is my belief that a man cannot hope to be trained spiritually, he may only train himself. A student from three years of emerging seminary training complaining of a lack of the operation of the Spirit within his own life cannot lay the blame to the seminary. We ourselves may be guilty of succumbing to that which we so often rant and rave about from the pulpit - the great American custom of passing the buck.

It must also be stated that the Seminary has, through various channels, provided for an expression of student opinion on the subject of our corporate worship. The Spiritual Life Commission is always open to comment, and suggestions from students on how the Seminary might better aid a student in his personal worship. In addition, this year a special committee on worship, consisting of two faculty members and two students, has been formed, and a report on the thinking of this committee will be forthcoming shortly.

In sheer volume he equals Barth; his grasp of form and structure matches the cathedral builders; his mastery of imagery and poetic expression rivals Shake speare.

But the significant point is that this musical genius expressed himself through the forms of faith. Many of his organ works were interpretations of familiar chorales. He composed over 200 cantatas directly related to the pericopal readings. He set vast sections of scripture to music -a body of expository material important to theologians and musicians alike. As Pelikan writes: "...the kerygma is reinforced by its association with other media of communication. The prime example of this, in a class by themselves, are the sacraments, in which external means are bearers of that grace which is the content of the kerygma. are not to be understood apart from the kerygma, yet they bear its grace with a special connotation all their own. There is an analogous and quasi-sacramental function to Christian art, too. Dependent for its validation upon the Word, it can nevertheless bring the Word in its own special way and thus aid in its communication. In the technique of doing this, Johann Sebastian Bach was a master."
