STATEMENT OF CONCERN, INVITATION FOR RESPONSE

TO THE SEMINARY COMMUNITY:

We as a collegium wish to express our concern over the lack of student participation in seminary policy making. We support the Seminarian Community Council's search for the re-instatement of standing committees such as the Academic Affairs and Campus Affairs Committees, or some working alternative(s), for the following reasons:

- 1. There is a lack of organized interchange of information between faculty and seminarians. Presently, there exists no officially recognized committee in which campus affairs and seminarian concerns may be voiced representationally during policy-making decisions. We note that the SCC is strictly a seminarian-oriented committee which cannot fulfill the need of a vehicle of communication between faculty and seminarians.
- 2. Such committees, or alternatives, as suggested above could provide the following services:
 - A. Juniors could participate in the shaping of programs which will affect their future as middlers and seniors. For example, student ideas concerning the 1976-77 Seminar Abroad could be elicited.
 - B. Seminarian opinions concerning admissions processes, grading policy, and programs for the January session could be represented
 - C. Such committees could be a training ground for seminarians to help them become acquainted with decision-making techniques in preparation for parish leadership.

We invite the views of other members of the community to discuss this concern over re-instatement of standing committees.

"THE LAND OF BURNING CHILDREN" (1904)

- As 144- 1 Seven years ago, Father Dan Berrigan Color coined the phrase which is the title of this peice to refer to Indochina. At the time, Lyndon Johnson was Vaging a secret, executive war in Laos; his administration was engaging in the Withering, terror bombing of Vietnam; and Cambodia, under Prince Norodom Sihanouk, was at relative peace with its neighbors. Today, peace has finally come to Laos; Vietnam continues to be an experience as important as the Holocaust, in terms of what it means to be human in the 20th century; and Cambodia, under General Lon Nol, suffers 300 casualties per day in a war now entering its fifth year.

Faced with this situation, Mr. Schlesinger, the Secretary of War, has requested -\$522 million in supplementary military aid for the tottering regimes in Phnom Pehh and Saigon in order to make possible continued fighting. That figure represents \$2.50 for the every American; that figure means that \$750,000 will leave Lancaster County for the military budgets of Thieu andLon Nol. According to the Defense Intelligence Agency ; from 1965 to 1973, the United States spent 33 times the amount on military aid to Indochina as the Soviet Union and People's China combined. Quite simply, for a decade, the American people have been rioped-off by a series of administrations Which have provided unlimited funds for a string of dicta. tors unworthy of one cent of aid or one drop [] of blood.

I urge everyone to telegram and/or write their Congresspersons and Semators in an effort to defeat these requests for "emergency" aid. The real emergency in the present period is not the military defeat of Thieu and Lon Nol, but the continuation of a decade of American-imposed horror in Indochina. History has presented us with this opportunity to end this atrocity now; that same history will judge us, if we fail to take advantage of it.

During the Week past, I have heard sounds of consternation concerning the words of advice and comment that appeared in last week, seeminarian under the thought-provoking title, "Huh?" In order to alleviate this consternation, allow me to share some insight gained from in-depth exploration.

Before looking at any specific items of the article, it is essential to understand the message in its full context. Obviously, it speaks to the individual soul in a communal way that speaks to the silent feelings that pervade our thoughts in an individual setting.

With this contextual setting complete. we turn to the first paragraph. The first half of the sentence is undentably of primary source, since the language is typical of other memos to appear from the desk of Dr. Jessup's mind. I do have reservations. however, about the second portion of the first paragraph. ("Huh?" FP 1, sen.2) Due to such terms as "hanky-panky,""obnoxious," "photo-electronic, "and "of," I question this passage as coming, indeed, from the historic Dr. Jessup. These words appear nowhere else in his writings, and probably, in all surety, are editor's deletions that have been introduced tim an evangelical use of this material in a pre-adolescent disa 3 closure to his/her specific audience.

The second paragraph, likewise, has enough typical Jessup syntax to view it with honest concern. Again, we find terms such as "quasi-ocular," "destroy, and "the" which are certainly not typical of his expression. Again I defer to the editorial problem of the Jessup oral tradition that continually tries to improve the excellence of the inferior syntactical structure.

This, of course, explains to us(at the risk; of sounding condescending to local authorities who constantly speak to the occasion - any occasion) the deep, true meaning of Dr. Jessup's timely words of mis-placed and irrelevant advice.

This leaves us only to consider the title. Concerning this subject, and others, I can say with authority, that it was, without concern of other influences and traditions, speaking to us, even in our situation, as yesterday, "Huh?"

In his essay, "Why Do Men Stupify Them- The Lord is my Pacesetter: selves?" Leo Tolstoy not only affirms the primacy of the human conscience, but also outlines the various means by which human beings attempt to dull their consciences to the overwhelming injustice and evil which surrounds them. This response is always far easier than constructive action in the face of the urgent need to organize to do that which would move humankind in the direction of peace and justice. This is, of course, the argument of the moralist. This may appear to be the introduction to a discussion of alcoholism as a societal evil. It isn't. I do hope, however, that womeone else will discuss that issue at a later date. At this Editor's note: Amen !!! time, my purpose is simply to point out the fact that 40 million people could be fed each year if the grain w hich would be used to feed them were not used to make alcoholic beverages. The Age of Alcoholic Innocence that is, stupefaction - is now over if we want to think of ourselves as responsible human beings and Christians when faced with this fact. The stated fee for M. Div. course work at LTS is \$40.00 per hour. Although courses vary in size, method, subject matter, etc. the charge per hour is the same for each hour of academic credit. The only reduction of this cost to individual students is in the form of scholarship grants and financial aid.

Some seminarians have asked for a special tuition rate for PT 351. This request has been under consideration since last October. Several consultations have been held with Dean Bricker and Prof. Irion. They have recommended a change in our policy in relation to this course, and the Executive Cabinet has begun a full-scale review of educational costs and the tuition rate. This review should result in a policy statement for discussion by faculty and seminarians, prior to submission to the Board of Trustees in May.

The Executive Cabinet has voted not to grant this request at this time. A preliminary statement of the issues and alternatives will be published in
