KOINONIA and COFFEE-CUPS

A member of the present staff of the SEMINARIAN recently made a social visit to that nearby stronghold of Lutheranism, Gettysburg Seminary. Besides being convinced by the visit that Gettysburg would be a "natural" for an inter-seminary Day of Prayer, such as the one this year between Lancaster and Lincoln, the staffer was delighted to find a solution to a problem here at our school?

It is no secret, of course, that many local seminarians grap a little "cup of brew" while their fellow students attend to the more lasting means of spiritual refreshment provided by our daily chapel periods.

Until recently our Entheran brethren also suffered from the same dilemma. In fact, even their professors were falling victim to the "coffee clutch" during the middle hour of the morning class schedule. Gettysburg, however, solved this little problem of theological consequence quite well.

The G-Berg Seminary schedule, well-fortified by the addition of a beautiful coffee-and-snack social room run on a student-co-op basis, now includes a twenty-minute coffee break each morning from 10:00 to 10:20. Students and professors alike, it is reported, rejoice over this "break" and the fellowship it provides in mid-morning. Those who don't "indulgence" also tag along, it seems, taking advantage of the koinonia, if not of the coffee!

This mid-morning break in the four-class morning schedule moves the chapel period up to 12:00 noon, at which time most everyone finds his way into the sanctuary for a twenty-minute devotional service before lunch time -- 12:30.

As they say in the MESSENGER, "We could try that!" Be that as it may, let us hope that a Day of Prayer arrangement with G-Berg can be made sometime. The 125 members of the student body there compare well with our own enrolment. Besides, our interests in Bookstore Cooperatives, the "married student problem," means to student governed affairs of administration, etc. would be well served by such a visit. Gettysburg is doing quite well many things which are still in the initial stages of development here. Along with the natural values of prayful fellowship with our Lutheran brethren we could also get some new practical tips.

THE "BIG BRASS" of the E. & R. Church foregathered in our Board Room on Wednesday, April 13th. The administrative committee, consisting mainly of the officers of the Church, were planning at that time for the 1956 meeting of the General Synod, to be held here at Lancaster's institutions. In the evening they met with Douglas Horton and C.C. leaders to discuss merger problems.

BOOK CO-OP PLANS AMENDMENT and SETS DEADLINES -- Carl Kreps

It was proposed by the Executive Committee of the Bookstore Cooperative that item 4, section 9, of the Co-op's constitution be repealed. This proposal was the principle concern of a special meeting of the executive group on April 13th. Along with the change in this amendment was the proposal that the term "sinking fund" be substituted for capital account" in this section.

The proposed amendment reads as follows (check the bulletin boards):
"The sum of 1 % shall be deducted from the net patronage refund of the Bookstore Cooperative at the end of each term, and placed in the Sinking Fund until that account shall reach the sum arrived at by the Executive Committee."

This proposal means two things to the stockholder and patron. First of all, it will mean that the Sinking Fund will not be limited from year to year by constitutional requirements; rather, the Executive Committee for each new year can set the limits of the Fund to meet current volumes of business and expense. Secondly, the I % deduction per term from the patrons' possible dividend will result in larger individual dividends every term in the long run -- this is better than the former 10 % deduction taken from the profits of one term only.

This amendment will be voted upon at a special meeting of all Co-op stockholders on the first Monday in May (the 2nd). While you are checking this date on your calendars and planning to attend, be sure to check any outstanding credit which you may have with the Co-op at present. The deadline for paying all current bills is May 10th. Other deadlines concerning final ordering dates are posted on the bulletin board in the administration building.
