LIFTING DEATH'S DARNNESS

This inspiring view of life and death recently appeared in the pages of a novel. During Leaf it soumed co-pecially appropriate to print a revised version of it in THE SETIMATIAN. Christianity stands on the promise that death is but a part of life. Such is the thought expressed herein. (Ed.)

Doath is no more terrible than birth. We can't understand it, any more than we can understand life or the sky at night. If we only had the vision to see the whole pattern of life, waid see death as something banign.

Suppose you couldn't remember anything from one day to the next. You'd get up in the morning without any recollection of yesterday. You'd feel full of energy. Der would be on the grass. The sun would be singing, and you'd feel that nature was a wonderful thing. Then the sun would rise in the heavens. You begin to get a little factigued.

Along about noon pould be tired, then clouds would blot out the sam. There'd be a thunder squall, and the heavens that had once been so friendly would be menacing. You'd see water falling out of the sky, and would wonder if you were going to be totally submerged. You'd see spurts of lightning tearing the sky apart. You'd hear roaring thunder. You'd be in terror.

Then the clouds would drift away. The sun would come out spain. The air would be pure and sparkling. You'd regain your confidence. Then you'd notice that the shadows were lengthening. The sun would disappear. There'd be darkness. You'd huddle around a light, waiting to see what would happen next. You'd feel weary, more than a little frightened. You'd think that Nature, which had started out to be so beautaful, had betrayed you. You'd fight hard to keep your faith, and it would be a losing battle.

The loved ones who were sitting around the fire with you would show signs of fatigue. Their heads would nod forward. They'd lie down. Their eyes would close, and suddenly their personalities would be gone. Then you yourself would want to lie down, and

yet you'd feel that as soon as you did this, the avful unconsciousness would overcome you.

My words don't carry conviction because you do know all of these symptoms as a part of life. You know that this unconsciousness is only sleep. You know that in the course of a few short hours, you'll wake up completely refreshed, that the dawn will be break-ing, that the sun will be coming up, the bards singing. You know that the awiw visitation of noise and flashes was only a thunder shower, part of Nature's scheme to bring water from the ocean up into the mountains, to feed the streams and rivers, to make all the crops green. You'd realize that sleep is Mature's means of strengthening you for a new day, that it's profitless to try to prolong the waking activities too far into the night, that Nature is co-operating with you. But suppose you didn't understand these things? Suppose you could see only from day to day?

Life is like that. We can only see from bursh to death. The rest is cut off from our vision.

FOURTH RURAL CHURCHMEN'S SEMINAR

From Tuesday, March 7, until Friday March 10, seventy-two persons from all parts of the country, representing in all twenty states, met in Washington, D. C., for the 4th Rural Churchmen's Seminar. There were eleven representatives of the E & R Church, seven of them from our Seminary. Present were Prof. and Mrs. Bartholomew, Mr. and Mrs. Geisler, Mr. and Mrs. McCrea, and Earlin Lutz.

Addresses and discussions were concerned with food surpluses, their disposal and distribution. Places of meeting were the U. S. Senate, Dept. of Agriculture, Dept. of the Interior, Dept. of Internal Revenue, State Dept., and the building of the Federation of Churches. Leaders were the Rev. Shirley Greene of the C. C. Church and Tom Keehn lobbyist for the C. C. Church. The delegates were housed throughout the city joining together in the evening meals at metropolitan churches.

Plans have been made to hold a similar Rural Churchmen's Seminar in the Spring of 1951, when our Seminary will again be represented.

REGIONAL INTER-SEM COMPARENCE HELD AT PRINCETON

Nine persons represented our Sendnary at the Princeton Conference held last Thursday to Saburday, United with some 250 seminarians from 17 other schools, they shared an inspiring and stimulating experience of ecumenical fellowship.

The theme, "Resources for the ministry", was unfolded by four main speakers. Four delegates have written the following resumes of the addresses.

The opaning address of the Princewton conference was delivered by Dr. W. E. Griffiths on the thems "The call to the ministry." at Union Service, Richard Vi. delivered the address. The number and the Bible". Dr. Hiller noted that the Bible is a divisive book because we go to it with presuppositions, particularly concerning the inspiration. Sometimes our faith must read on more than inspiration alone. A saffying Bible must be heard by an open mind. In the ministry, the Bible has a h-fold function: (1) it is an instrument by which souls are numbered; (2) it is the supreme source of theology; (3) it should be the source of our preaching; and (4) it should be used in pastoral work.

"The minister and prayer" was the theme of Douglas Steer's address. Thru vivid illustrations Dr. Steers pointed out the need for preyer to the minister who takes serious his responsible lity for his parashoners. He showed what prayer can do for the minister; (1) it rominds us that altho we are not adequate to our bask, ded is adequate; (2) it restores proper perspective in any given situation, both cutting us down to size and buoying us up; (3) it greatly influences the character of our sermons; (h) it is the only way of resolving conflicts between our professed beliefs and our conduct. Dr. Steere said that the greater the book, the greater is the need for prayer. If we are relatively indifferent to prayer at times, we might ask, "Is my fail... ure to pray due to the shallowness of my antivities?"

The fourth speaker was W. N. Pittenger, since 1935 on the faculty of The General Theological Seminary, New York Ciry. The author of 14 books, he has been a member of the Study Commission of the World Council of Churches since 1940. Dr. Pittenger discussed "The communion of maints" from the viewpoint of a conservative Anglican. The Church is the communion of the saints. The minister functions as the agent of God in the production of sanctity. We can never hope to attain perfection, for man is a sinner even when radesmed. The communion of the saints is also a vertical fellowship. Those close to God, already in the Church Triumphant, are hely or being made holy. Though we may not pray to them, we may ask them to pray for us.

It might prove an interesting exerrise to ask a group of people just when this bit of poetry was written. Probably many would say that it is a modern idea, advanced by someone who is steeped in modern secularism and materialism.

However, contrary to such an opinion, this was written by Robert Herrich in 1647. It is more than three hundred years since these lines were composed.

Resently a member of St. James' Church remarked that she was surprised by a proposed lenten program that would follow weekday services with a social period in the parish house. She felt that this was not in keeping with the secrificial note of Lent. She had been raised to view Lent as a time of self-denial. Such an idea was new to her.

It seems that there is very little popular comprehension of the true meaning of Lent. It is also certain that this season in the church year might have more significance if its meaning were more widely spread among Christian people.

The Sunday before Lent began there was this brief paragraph on the back of a church bulletin, presenting a concise statement of the significance of Lent.

AS I SEE IT . . . (Contid from p.2)

"The Lenten season from Ash Wednesday to Easter includes forty week days and six Sundays. Lent, from the Angle-Saxon "Lencten" meaning spring, is a season of spiritual renewal; not a retreat from life, but a renewal of life. To renew our spiritual life, the public worships of the Church will be regularly and reverently attended; private devotions will be faithfully observed; earnest efforts will be made to win men and women to Christ."

Therefore, we can say that Lent is a time for rejoicing, worship, meditation, and evangelism.
