EDITORIAL

The expression, "Life is too short to be small," has been used so extensively that for many of us it has ceased to have any significant value. Neverthless, that statement is a valid one and we might do well to apply it to our life here in the Seminary. Perhaps the desire for praise and flattery is a reflection of our own smallness. Little people like to feed their ego with a steady diet of praise and adoration. But the capacious soul socks truth and is aware of the fact that sincere criticism is of vast importance to such an objective. How fortunate we are to have among the laity such men as Elmer A. Jacoby who is willing to take a bit of time to make helpful suggestions to us who have dedicated our lives to the service of God and the Church. If. Jacoby has devoted fifty-three years of his life to the field of education. He has accepted our invitation to come here to the Seminary to speak to us about the training of a student for the ministry from the layman's viewpoint. In a letter to Dr. Frantz he made some excellent suggestions to the student preparing for the Christian ministry. We consider it a great privilege to have been granted the permission to reprint in full Mr. Jacoby's letter.

Dear Dr. Frantz:

I trust that as a layman of the Evangelical and Reformed Church I may be permitted to present cortain conclusions I have reached in regard to the training students for the ministry receive. The opinions herein expressed and the conclusions reached are based not alone on observation and contacts within our own denomination, but on that of sister denominations and through conversations with leading lay members of those denominations. To put it briefly, I have concluded that the courses at most of the Theological Seminaries lack certain things necessary to prepare adequately a young man for the ministry.

- 1 Many ministers have poor voice control. Voice culture and public speaking should be part of the curriculum.
- 2 Hany ministers ofter years of experience have a poor delivery. A pleasing voice and a good delivery cover defects in a good sermon

- 3 Students should be impeased with the necessity of peing "good mixers" and of adjusting themselves to different types of individuals. In my estimation these traits will be much to smooth a minister's path.
- 4 -- Ministers should be incorrected to atudy and understand the personality of the consengation. Congressionality as individuals do, A complete understanding of this condition is productive of results.
- . 5 Ministers are called to nerve congregations and the service should be of a nature to enrich the members spiritually.

- 6 Students should be impressed with the necessity of developing lay leadership. In many congregations this is a hard and thankless task. I know. However, it is one which increases the efficiency of a congregation.
 - 7 Young ministers need practical and concrete instruction in organizing -- especially committees in the consistor-ies which can be very helpful to a pastor.
 - 8 The matter of pastoral visitation is most important andunfortunately today this is being omitted in a large measure.
- 10 Lastly, a larger number of young men of outstanding ability should be encouraged to enter the ministry.

 Possibly this is largely a congregational responsibility.

 Lay membership should, no doubt, strive to make the profession more remunerative and more attractive.

I admit this is a big problem and it has many ramifications that a solution may be difficult.

The above statements are not made in a spirit of harsh criticism. Rather, it is giving vocal expression to thoughts that have, long occupied my mind.

If in the future an opportunity should present itsolf, nothing would afford me greater pleasure than to sit down and discuss these questions in a friendly manner.

THE TASK OF THE CHURCH

. 2 4 The Church is very conscious today of the need for re-thinking the purpose for which it exists, and the goal toward which it should strive, I believe that in any discussion of the task of the church there are two dangers which one must avoid. The one obvious danger is to assume that the Church has no function to fulfill in the modern world, By some writers the Church is regarded as an outmoded institution which is linguring on as a dispensary of opium for the weak and uneducated people. Those of us who are in Seminary are convinced that the Church has a more vital part to fill in our civilization than to sooth the fears of timid souls with pious pintitudes. We should bear in mind, however, that much of the emitionsm of the Church is justified, It is equally fallacious to conceive of the Church as the Kingdom of God. The Church is far from being a perfect institution and it's limitations are such that although it maybe the forerunner of the Kingdom, it can certainly not be the Beloved Community of Love and Hope for which men have prayed, We ought to think realistically of the Church if we are to contribute anything to its advancement. When we look at the Church Penestly we are impressed by what Dr. Visser't Hooft called The Wrotchedness and the Greatness of the Church The most obvious rechrost of the Church Is that it is a community of human beings, and lugar beings are finite and sinful. We should bear in mind that the Church does not consist of saints. Today we are faced with thousands of Church members who have no working conception of the function of the Church. As a result, In many sections, the Church has become a social cluy, Undoubtedly church members who think of the Church as a perfect society are shocked when they discover that the Church practices racial, social and economic Effectimenation. That social discrimination by churches can be confirmed by reading Pope's Millhands. and Preachers.

The most distressing limitation of the Church is the result of insufficient and poorly trained Inaders. It is common to regard a minister as a person of mediocre intelligence, and one even hears laymen question the spiritual sincerity of some pasters. When we remember that in 1935, a survey showed that only slightly more than 20 per cent of the ministers in 19 white denominations had been educated in colleges and seminaries, then we can appreciate some of the criticisms leveled against the ministers. Bonnett in an article In The Gospel, the Churchm and the World reports that one of the faults of the Protestant ministers lies in their sermons which contain either "'dry rot" or an irrelevant idealism." The church will be improved only as more and more leaders become aware of the tremendous challenge facing the institution which they are serving. Bennett says, "It is not altogether the minister's fault but it is a symbol of his prodicament that too often books are a luxury whereas gasoline is a necessity." Unless a minister has a definite purpose in mind, social activism will merely dissipate his energy. Nothing has shocked me more than to hear some ministers toll mo that they are too busy to read any books on theology. I doubt whether many doctors or lawyers could long maintain an active practice unless they kept up with the latest sceintific and legal findings. A minister is a specialist in theology and for his own sake should take time to read some serious works during the year,

I have already written too much concerning the wretchedness of the Church. We must remember that all is not dark; the light is still shining. The Church is advancing toward the goal of the Kingdom of God, but this advance does not take place on an escalator. Only as pasters and laymen strive for the purification of the temporal church and the advancement of the Kingdom will be achieve progress. The revival in seminaries is of utmost significance. We are learning that the Church does have a vital function to play in our world. It is to be the religious teacher of mankind, the prophet of social reform, and the organizer of an ecumenical religious followship which shall know no bounds. It is our duty to dedicate ourselves to the purification of the Church as well as to serve as pasters and praachers. There is no other organization

in the world which can meet the spiritual needs of mankind; it is our task to make the Church so efficient that the Kingdom may grow in depth and width. The Church has a tremendous task for it is the force which is working in the world to realize spiritual values. It is responsible for orienting man to think of God first, and self. second. The Church must try to get society to center its life on the inherent value of persons than on economic factors. All this is idealism of a cort. When I look at the Church I adopt what Father Tyrrell called "a provisional possimism but an ultimate optimism." The Church is of the earth and yet is of God. The Church is imperfect and yet potentially it is capable of perfection. The task of the Church is to bring man to God, yet God is seeking man! My optimism concerning the capacity of the Church for achieving its task is grounded on two pillars: (1) There is no other organization in our society which he capable of assembling sufficient consecrated resources for the toak of spiritualization. (2) God is seeking to help man build a Beloved Community and any organization which is dedicated to his purpose is, in a sense, controlled by. God. The invisible Church, which is never the same as the visible Church consists of all those persons who are striving to do the ... will of God. Fortunately, a large proportion of the members of the invisible Church are also members of the visible churches. With these sincere persons who are striving to become co-creators with God we must put our trust, The Church must redoem society, but first it must redeem itself.

TILI PASSION, DARCH AND DESURRECTION OF COLUMN AND SELECTS

All of us are fully aware of the trameadous impact symbolism in Christian Art has had upon the Church down they the centuries. Practically everymajor truth in the realm of the Christian religion has been represented in some form or another by the use of symbols. We are all familiar I am sure with the various symbols that represent God, the Holy Spirit, Our Lord Jesus Christ, the Gospels and the Church as well as some of the central teachings of Our Lord.

Among the many symbols which have a special significance and meaning for this particular season of the Church Year are those which deal with the Passion, Death and Resurrection of Our Lord Jesus Christ. Practically every detail of the records in the Cospels which tell the story of Our Lord's sufferings has been represented in Christian art by a symbol. Below I have recorded the most important of these symbols, those which are most likely to be seen in st-ined glass church windows, in carvings and other places within the sanctuary.

- 1 A CHALICE AID A CROSS: represent the agony of Christ in the Garden of Gethsemane. The cross in this case is known as "the Cross of Suffering" or "the Cross of Agony," and is distinguished by the pointed ends. This symbol is often seen on stained glass windows.
- 2 A LANTERN:

 is a symbol of Our Lord's betrayal which took place at night in the Gorden. The proper reference to the incident is John 18:3 from which the symbol of THE TORCH is also derived.
- 3 THE SWORD AND STAFF: is another symbol of Our Lord's betrayal. The group that came with Judas to seek Him out were armed, you will recall, with swords and staffs.
- 4 PURSE AND THIRTY PIECES
 OF SILVER:
 Represents the price of Judas' perfidy.
- ### TWO SCOURGES (crossed like an X) against a whipping POST represent the scourging and torture of Our Lord at the hands of the Roman Soldiers in the Armory. Symbol based on Matt. 27:26 and Mark 15:15.
- 6 CROWN OF THORMS INTERWOVEN

 ABOUT THREE MAILS

 Symbolize the torture and crucifixion of Our Lord. Frequently the three nails are used separately as a symbol of the crucifixion. Sometimes the initials INRI are inserted in the space enclosed by the thorms.
