

REFORMATION AND THE ROMAN CATHOLIC CHURCH

Anyone who reads a daily paper this fall cannot help but be aware of the increasing pace with which the fathers of the Secind Vatican Council are moving for the reform of the Roman Church with a view to the reunion of all Christians. Nearly every question which Protestants would raise about the practice and doctrine of the Roman Catholic Church is being faced op openly by the Council with particular attention to the teaching of the Scriptures.

The schema on the liturgy revolutionary in its insistence upon a sermon with Sunday mass and in its opening the way to the use of the vernacular - is being adopted with only a handful of dissent- subjected to rigorous consideraing votes. The schema on the church among other things stresses the universal priesthood of Christians and the lay apostolate, takes the first steps toward qualifying the teaching concerning papel infallibility, and acknowledges that all who are baptized belong to the church of Jesus Christ.

No doubt the revised schema on scripture and tradition will be presented at this fall's session. There can be little question but that it will open the door for fruitful discussion between Roman Catholic and Protestant theologies. all of the churches. The schema originally proposed would not only have closed the door to further discussion but also would have condemned the views of a number of leading European Cathblicascholars. From statements made made by those closely associated with the presidium of the Council it seems likely that before the Council closes (and that might be after two more years in view of



the new openness of the fathers) every major item to which Protestants might voice objection, including birth control and the ante-nuptial contract, will be tion by the fathers with the hope of expressing the Roman Church's position in a more pastoral way.

It seems to me that there is a twofold response which a Protestant ought to make to the work of the Council. He first ought 50 thank God that the Holy Spirit is renewing the Church of Rome. And then he ought to turn his attention to his own church, consider its life and faith in the light of the Scriptures, and pray for the mighty rushing wind of the Spirit to cleanse and renew



### RENEWAL IN THE CHURCH

The current concern for renewal in the Church grows out of a fresh understanding of both the faith and the facts. Biblical theology, on the one hand, and the insights of social diagnosticians on the other, have combined to force an agonizing reappraisal of the spiritual health and the institutional structures of Christen

The fighting words of renewal are: "God so loved the world ..!" Drawing on New Testament themes. Jesus Christ is Lord of the whole cipalities and powers as well as the private sector of the soul). God became a man (not a stone or an langel), and Christ died on behalf of man; therefore God has an unequivocal rehumanizing care for man - renewers are calling the Church out of its ghetto-like preoccupation with institutional success and the applause of the crowd, to a servant-style ministry in the public arenas of anguish: war and peace, race, unemployment, In addition to the benefits themass leisure, etc. The present kairos demands a world-oriented Church and a world-drenched theo-

Viewing the laity as the gift ministry that God has given the Church (I Cor. 12) for its basic witness in the world (the laity live in the structures), the renewers see the clergy as the catalytic agent that "equips the saints for their work of ministry"



(Ephesians 4) in the secular world.

The question that the soci**olo**gists and their interpreters put to the Church in the light of the concern for renewal is: Are your inherited structures geared to mission? Are they in a real sense in touch with the marketplaces where 20th century life is lived, where the agonies of men are experienced, where lies the power to do something about those agonies, where the people are who are estranged from the Church? Does the Church have only "come" structures, or does it also have "go" structures?

These questions have led controlled to thurchmen to experiment with new forms: within the parish (house churches, retreats, public diaconate, vocational study and action groups, marketplace evangelism), alongside the parish (coffeehouses, lay training centers, chaplaincies in work and leisure worlds, evangelical academies, faith and life communities), above the parish (dialogue with people in the power structures, supra-parochial social action).

In the enthusiasm for Christian renewal vis a vis the common life, and in reaction against the pietism that expresses loyalty to a personal Savior but denies its public Lord, the renewers sometimes tend to obscure the crucial, personal dimensions of the Gospel sin, guilt, finitude, death, newal must include also a profounder grapple with the I\*Thou encounter that heals those alienations together in the world-historical witness, and be implemented by a comparable aggiornamento in the teaching, preaching, liturgical and organizational life of the Church.

My continual amazement at the amount of honest concern displayed by extra-ecclesiastical service organizations leads me to confess that much of the work they are doing should be the concern of the church. It is damning to the church when her professing members become more actively involved in the work of the Rotary or Garden Club, simply because these societies demonstrate a greater social consciousness than does the church

Our perspective within the church is unique - that of God in Christ Jesus - and no other organization can wholeheartedly profess to this uniqueness. Further, it is primarily on the level of the parish community that Christian concern can be concretely taught and displayed.
