- FROM imposing, levying, and collecting of any SPECIAL SALES tax upon
- sales of CIGARETTES, tobacco products, OR NICOTINE PRODUCTS, AS THAT
- 30 TERM IS DEFINED IN SECTION 18-13-121 (5), or upon the occupation or
- 31 privilege of selling such CIGARETTES, TOBACCO PRODUCTS, OR NICOTINE
- 32 products. by any city or town in this state, nor shall the provisions of This
