Second Reading

1 Amend reengrossed bill, page 5, line 14, after "TIME." insert "EACH
2 INSPECTING ENTITY'S PROCEDURES MUST INCLUDE PROVISIONS THAT
3 ALLOW FOR INSPECTORS TO CONDUCT OCCASIONAL, RANDOM, ON-SITE
4 INSPECTIONS WHILE ACTUAL PLUMBING WORK IS BEING CONDUCTED, WITH
5 A FOCUS ON LARGE COMMERCIAL AND MULTI-FAMILY RESIDENTIAL
6 PROJECTS PERMITTED BY THE INSPECTING ENTITY."

7 Page 5, after line 24 insert:

8 "(c) THE BOARD SHALL ENSURE COMPLIANCE WITH THIS SECTION.
9 IF THE BOARD DETERMINES, AS A RESULT OF A FORMAL COMPLAINT, THAT
10 AN INSPECTING ENTITY IS CONDUCTING PLUMBING INSPECTIONS THAT DO
11 NOT COMPLY WITH THIS SECTION, THE BOARD MAY ISSUE TO THE
12 INSPECTING ENTITY AN ORDER TO SHOW CAUSE, IN ACCORDANCE SECTION
13 12-58-104 (1)(m), AS TO WHY THE BOARD SHOULD NOT ISSUE A FINAL
14 ORDER DIRECTING THE INSPECTING ENTITY TO CEASE AND DESIST
15 CONDUCTING PLUMBING INSPECTIONS UNTIL THE INSPECTING ENTITY
16 COMES INTO COMPLIANCE TO THE SATISFACTION OF THE BOARD. IF THE USE
17 OF STATE PLUMBING INSPECTORS IS REQUIRED AFTER THE ISSUANCE OF A
18 FINAL CEASE-AND-DESIST ORDER PURSUANT TO THIS SUBSECTION (10)(c),
19 THE INSPECTING ENTITY SHALL REIMBURSE THE BOARD FOR ANY EXPENSES
20 INCURRED IN PERFORMING THE INSPECTING ENTITY'S INSPECTIONS, IN
21 ADDITION TO TRANSMITTING THE REQUIRED PERMIT FEES."

22 Page 8, line 16, after "TIME." insert "EACH INSPECTING ENTITY'S
23 PROCEDURES MUST INCLUDE PROVISIONS THAT ALLOW FOR INSPECTORS TO
24 CONDUCT OCCASIONAL, RANDOM, ON-SITE INSPECTIONS WHILE ACTUAL
25 PLUMBING WORK IS BEING CONDUCTED, WITH A FOCUS ON LARGE
26 COMMERCIAL AND MULTI-FAMILY RESIDENTIAL PROJECTS PERMITTED BY
27 THE INSPECTING ENTITY."

28 Page 8, after line 25 insert:

29 "(c) THE BOARD SHALL ENSURE COMPLIANCE WITH THIS SECTION.
30 IF THE BOARD DETERMINES, AS A RESULT OF A FORMAL COMPLAINT, THAT
31 AN INSPECTING ENTITY IS CONDUCTING PLUMBING INSPECTIONS THAT DO
32 NOT COMPLY WITH THIS SECTION, THE BOARD MAY ISSUE TO THE
33 INSPECTING ENTITY AN ORDER TO SHOW CAUSE, IN ACCORDANCE SECTION
34 12-155-105 (1)(m), AS TO WHY THE BOARD SHOULD NOT ISSUE A FINAL
35 ORDER DIRECTING THE INSPECTING ENTITY TO CEASE AND DESIST
36 CONDUCTING PLUMBING INSPECTIONS UNTIL THE INSPECTING ENTITY

1 COMES INTO COMPLIANCE TO THE SATISFACTION OF THE BOARD. IF THE USE
2 OF STATE PLUMBING INSPECTORS IS REQUIRED AFTER THE ISSUANCE OF A
3 FINAL CEASE-AND-DESIST ORDER PURSUANT TO THIS SUBSECTION (10)(c),
4 THE INSPECTING ENTITY SHALL REIMBURSE THE BOARD FOR ANY EXPENSES
5 INCURRED IN PERFORMING THE INSPECTING ENTITY'S INSPECTIONS, IN
6 ADDITION TO TRANSMITTING THE REQUIRED PERMIT FEES."
