HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public Health Care & Human Services.

HB19-1142 be amended as follows:

- 1 Amend printed bill, page 3, strike lines 8 through 22 .
- 2 Renumber succeeding subsection accordingly.
- 3 Page 4, lines 7 and 8, strike "ARTICLE 6 AND ARE NOT SUBJECT TO THE
4 LICENSING REQUIREMENTS OF FOSTER CARE." and substitute "ARTICLE 6."
- 5 Page 7, line 10, strike "INVESTIGATION;" and substitute "INVESTIGATION
6 IN THE SAME MANNER AS DESCRIBED IN SECTION 26-6-107 (1)(a)(I)(C)."
- 7 Page 7, lines 11 and 12, strike "ON THE TRAILS SYSTEM, AS DEFINED IN
8 SECTION 16-20.5-102 (10);" and substitute "PURSUANT TO SECTION
9 19-1-307;"
- 10 Page 7, line 14, strike "REGISTRY" and substitute "WEBSITE".
- 11 Page 8, line 9, strike "A TEMPORARY CARE PROVIDER" and substitute "AN
12 APPROVED TEMPORARY CAREGIVER".
- 13 Page 8, strike lines 21 through 27 and substitute:
14 **"26-6-705. Rules.** (1) A TEMPORARY CARE ASSISTANCE PROGRAM
15 AND A TEMPORARY CARE PROVIDER ARE SUBJECT TO ANY RULE
16 PROMULGATED BY THE DEPARTMENT THAT IS APPLICABLE TO
17 NONCERTIFIED KINSHIP CARE, DEFINED IN SECTION 19-1-103 (78.7);
18 EXCEPT THAT A TEMPORARY CARE ASSISTANCE PROGRAM AND A
19 TEMPORARY CARE PROVIDER ARE NOT SUBJECT TO SUCH A RULE THAT IS
20 INCONSISTENT WITH THIS PART 7.
21 (2) EXCEPT AS PROVIDED IN SUBSECTION (1) OF THIS SECTION, A
22 TEMPORARY CARE ASSISTANCE PROGRAM AND A TEMPORARY CAREGIVER
23 ARE NOT SUBJECT TO ANY RULE PROMULGATED BY THE DEPARTMENT FOR
24 AN ACTIVITY PERFORMED PURSUANT TO THIS PART 7."
- 25 Page 9, strike lines 1 through 12.
- 26 Page 10, strike lines 16 through 19 and substitute "ANY PERSON REQUIRED
27 TO SUBMIT TO A BACKGROUND CHECK PURSUANT TO SECTION 26-6-704
28 (2), WHEN THE".
- 29 Page 10, line 20, strike "OTHER".
- 30 Page 10, strike lines 23 through 27.

- 1 Renumber succeeding section accordingly.
- 2 Page 11, strike lines 1 through 6.
- 3 Strike "QUALIFIED NONPROFIT ORGANIZATION" and substitute "CHILD
- 4 PLACEMENT AGENCY" on: **Page 3**, line 24; **Page 4**, line 3; **Page 6**, line 24;
- 5 **Page 7**, line 3, line 19, line 22, and line 24; **Page 8**, lines 1 and 2, line 7,
- 6 and line 16.
