

## HOUSE FLOOR AMENDMENT

Second Reading

1 Amend the Finance Committee Report, dated March 4, 2019, page 1,  
2 after line 4 insert:

3 "Page 5 of the bill, strike lines 9 and 10 and substitute:

4 "(g) "REMOTE NOTARIZATION SYSTEM" MEANS AN ELECTRONIC  
5 DEVICE OR PROCESS THAT:

6 (I) ALLOWS A NOTARY PUBLIC AND A REMOTELY LOCATED  
7 INDIVIDUAL TO COMMUNICATE WITH EACH OTHER SIMULTANEOUSLY BY  
8 SIGHT AND SOUND; AND

9 (II) WHEN NECESSARY AND CONSISTENT WITH OTHER APPLICABLE  
10 LAW, FACILITATES COMMUNICATION WITH A REMOTELY LOCATED  
11 INDIVIDUAL WHO HAS A VISION, HEARING, OR SPEECH IMPAIRMENT."

12 Page 5 of the bill, after line 17 insert:

13 "(i) "REMOTELY LOCATED INDIVIDUAL" MEANS AN INDIVIDUAL  
14 WHO IS NOT IN THE PHYSICAL PRESENCE OF THE NOTARY PUBLIC WHO  
15 PERFORMS A NOTARIAL ACT UNDER THIS SECTION."."

16 Page 1, strike lines 8 and 9 and substitute "NOTARIZED DOCUMENT FOR ITS  
17 INTENDED PURPOSE."."

18 Page 1, lines 13 and 14, strike "OBLIGATIONS IMPOSED BY APPLICABLE  
19 STATE" and substitute "LOCAL GOVERNMENT, STATE,".

20 Page 1, after line 14 insert:

21 "Strike "ANOTHER INDIVIDUAL" and substitute "A REMOTELY LOCATED  
22 INDIVIDUAL" on: **Page 3** of the bill, lines 15 and 24.

23 Strike "THE INDIVIDUAL" and substitute "THE REMOTELY LOCATED  
24 INDIVIDUAL" on: **Page 4** of the bill, line 6; **Page 5**, lines 15 and 27; **Page**  
25 **6**, lines 1 and 2; **Page 7**, lines 8, 19, 23 and 24, and 27; **Page 8**, lines 6,  
26 10, 14, 16, and 20; **Page 12**, lines 19 and 22; **Page 13**, lines 15, 18, 20,  
27 and 22, 24 and 25, 25 and 26, and 27; **Page 14**, lines 6, 7, and 13; and  
28 **Page 15**, line 26.

29 Strike "AN INDIVIDUAL" and substitute "A REMOTELY LOCATED  
30 INDIVIDUAL" on: **Page 5**, lines 7 and 21 and 22; and **Page 7**, lines 2 and  
31 3."
