HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB19-1199 be amended as follows:

- 1 Amend printed bill, page 4, line 13, strike "AT THE TIME OF REGISTRATION  
2 OF EVERY" and substitute "WHEN THE OWNER OF AN".
- 3 Page 4, line 14, strike "AND".
- 4 Page 4, line 15, strike "FEE," and substitute "FEE PAYS THE OTHER FEES  
5 AND SPECIFIC OWNERSHIP TAX REQUIRED FOR THE ANNUAL REGISTRATION  
6 OF THE VEHICLE,".
- 7 Page 5, lines 2 and 3, strike "AT THE TIME OF REGISTRATION OF AN  
8 ELIGIBLE PLUG-IN ELECTRIC MOTOR VEHICLE, THE OWNER OF THE  
9 VEHICLE" and substitute "WHEN THE OWNER OF AN ELIGIBLE PLUG-IN  
10 ELECTRIC MOTOR VEHICLE PAYS THE OTHER FEES AND SPECIFIC  
11 OWNERSHIP TAX REQUIRED FOR THE ANNUAL REGISTRATION OF THE  
12 VEHICLE, THE OWNER".
- 13 Page 11, line 2, after "THE" insert "OWNER OF THE".
- 14 Page 11, lines 3 and 4, strike "IS REGISTERED WITHOUT THE OWNER OF THE  
15 VEHICLE" and substitute "PAYS THE OTHER FEES AND SPECIFIC OWNERSHIP  
16 TAX REQUIRED FOR THE ANNUAL REGISTRATION OF THE VEHICLE  
17 WITHOUT".
- 18 Page 11, line 6, strike "OR".
- 19 Page 11, lines 6 and 7, strike "THE VEHICLE IS REGISTERED BY" and after  
20 "NEW" insert "PAYS THE FEES AND SPECIFIC OWNERSHIP TAX REQUIRED  
21 FOR THE ANNUAL REGISTRATION OF THE VEHICLE".
- 22 Page 11, lines 8 and 9, strike "BY ANY SUBSEQUENT OWNER FOR ITS FIRST,  
23 SECOND, OR THIRD REGISTRATION PERIOD" and substitute "WHEN ANY  
24 SUBSEQUENT OWNER PAYS THE FEES AND SPECIFIC OWNERSHIP TAX  
25 REQUIRED FOR THE ANNUAL REGISTRATION OF THE VEHICLE FOR ITS  
26 FOURTH REGISTRATION PERIOD,".
- 27 Page 11, line 10, after "AND" insert "THE VEHICLE".
- 28 Page 11, lines 13 and 14, strike "ON THE DATE OF THE FIRST" and  
29 substitute "WHEN THE OWNER OF THE VEHICLE TO WHICH THE STICKER OR  
30 DECAL IS AFFIXED FIRST PAYS THE FEES AND SPECIFIC OWNERSHIP TAX  
31 REQUIRED FOR THE ANNUAL".

1 Page 12, line 3, strike "FEE TO BE PAID UPON THE REGISTRATION" and  
2 substitute "FEE, WHICH ACCESS FEE IS IMPOSED AS OF THE DATE ON WHICH  
3 THE OWNER OF THE VEHICLE APPLIES FOR INITIAL REGISTRATION OF THE  
4 VEHICLE IN THE STATE OR AS OF THE DATE ON WHICH THE DEPARTMENT OF  
5 REVENUE OR AN AUTHORIZED AGENT OF THE DEPARTMENT OF REVENUE  
6 TRANSMITS A REGISTRATION RENEWAL NOTICE TO THE OWNER OF THE  
7 VEHICLE, TO BE PAID TOGETHER WITH THE OTHER FEES AND SPECIFIC  
8 OWNERSHIP TAX REQUIRED FOR THE ANNUAL REGISTRATION".

9 Page 12, lines 25 and 26, strike "IN ITS FIRST, SECOND, OR THIRD YEAR OF  
10 SERVICE" and substitute "BEING REGISTERED FOR ITS FIRST, SECOND, OR  
11 THIRD REGISTRATION PERIOD".

12 Page 13, line 4, strike "ENTERPRISE," and substitute "ENTERPRISE AS OF  
13 THE DATE THAT THE TRANSPORTATION ENTERPRISE WOULD OTHERWISE  
14 IMPOSE AN EXPRESS LANE ACCESS FEE PURSUANT TO SUBSECTION  
15 (2)(c.5)(I) OF THIS SECTION,".
