HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB19-1215 be amended as follows:

1 Amend the Public Health Care and Human Services Committee Report,
2 dated March 15, 2019, page 1, strike lines 1 and 2 and substitute:

3 "Amend printed bill, page 3, line 2, strike "(7)(a)(II)(F)",

4 Page 3, strike lines 8 through 15 and substitute:

5 "(c.5) "MANDATORY SCHOOL FEES" MEANS FEES CHARGED BY A
6 SCHOOL OR SCHOOL DISTRICT, INCLUDING A CHARTER SCHOOL, FOR A
7 CHILD ATTENDING PUBLIC PRIMARY OR SECONDARY SCHOOL FOR
8 ACTIVITIES THAT ARE DIRECTLY RELATED TO THE EDUCATIONAL MISSION
9 OF THE SCHOOL, INCLUDING BUT NOT LIMITED TO LABORATORY FEES;
10 BOOK OR EDUCATIONAL MATERIAL FEES; SCHOOL COMPUTER OR
11 AUTOMATION-RELATED FEES, WHETHER PAID TO THE SCHOOL DIRECTLY OR
12 PURCHASED BY A PARENT; TESTING FEES; AND SUPPLY OR MATERIAL FEES
13 PAID TO THE SCHOOL. "MANDATORY SCHOOL FEES" DOES NOT INCLUDE
14 UNIFORMS, MEALS, OR EXTRACURRICULAR ACTIVITY FEES."

15 Page 4, line 10, after "that" insert "OR IS EMPLOYED PART-TIME WHILE
16 ENROLLED IN A PART-TIME EDUCATIONAL OR VOCATIONAL PROGRAM,
17 BASED ON THE INSTITUTION'S ENROLLMENT DEFINITIONS,".

18 Page 4, strike lines 16 through 21 and substitute "support available to a
19 child."

20 Page 5, strike "ASSETS AND RESIDENCE;" and substitute "ASSETS;".

21 Page 5, after line 5, insert "(B) RESIDENCE;".

22 Reletter succeeding sub-subparagraphs accordingly.

23 Page 5, line 16, strike "WILLING TO HIRE THE PARENT" and substitute
24 "HIRING IN THE COMMUNITY, WITHOUT CHANGING EXISTING LAW
25 REGARDING THE BURDEN OF PROOF;".

26 Page 6, strike lines 22 through 27 and substitute "~~required of the obligor.~~
27 The minimum order amount shall not apply when each parent keeps the
28 children more than ninety-two overnights each year as defined in
29 ~~paragraph (h) of subsection (3)~~ SUBSECTION (3)(h) of this section. In no
30 case, however, shall the amount of child support ordered to be paid
31 exceed the amount of child support that would otherwise be ordered to be
32 paid if the parents did not share physical custody."

- 2 Page 8, line 9, strike "IF AN OBLIGOR'S" and substitute "FOR AN OBLIGOR
3 WITH AN".
- 4 Page 8, line 10, strike "IS" and substitute "OF".
- 5 Page 1 of the committee report, strike lines 4 through 15 and substitute:
- 6 "Page 8, strike lines 16 through 25 and substitute "(9) to (11) of this
7 section, IF, AFTER THESE ADJUSTMENTS ARE MADE, THE OBLIGOR'S CHILD
8 SUPPORT AMOUNT DOES NOT EXCEED TWENTY PERCENT OF THE OBLIGOR'S
9 ADJUSTED GROSS INCOME. ADJUSTMENTS MUST NOT BE MADE TO THE
10 OBLIGOR'S CHILD SUPPORT AMOUNT PURSUANT TO THIS SUBSECTION
11 (7)(a)(II)(C) IF, WITHIN THE SAME CHILD SUPPORT ORDER, THE NUMBER OF
12 CHILDREN FOR WHOM A DUTY OF SUPPORT IS OWED RESULTS IN A CHILD
13 SUPPORT OBLIGATION THAT EXCEEDS TWENTY PERCENT OF THE OBLIGOR'S
14 ADJUSTED GROSS INCOME. The low-income adjustment shall not apply
15 when each parent keeps the children more than ninety-two overnights
16 each year as defined in subsection (8) of this section, In no case, however,
17 shall the amount of child support ordered to be paid exceed the amount
18 of child support that would otherwise be ordered to be paid if the parents
19 did not share physical custody."

- 21 Page 10, strike line 1.
- 22 Page 33, strike lines 5 and 6 and substitute "**updates.** (g) FOR PURPOSES
23 OF CALCULATING CHILD SUPPORT, WHEN TWO OR MORE".
- 24 Page 33, strike line 10 and substitute "OVERNIGHTS USED TO DETERMINE
25 CHILD SUPPORT".
- 26 Page 33, strike lines 14 through 26.
- 27 Strike page 34.
- 28 Page 35, strike lines 1 through 21.
- 29 Page 37, line 8, after the period add "AFTER THE PERIODIC REVIEW
30 DESCRIBED IN THIS SECTION, THE COMMISSION SHALL SUBMIT A REPORT TO

1 THE GOVERNOR AND TO THE GENERAL ASSEMBLY EXPLAINING THE
2 COMMISSION'S RECOMMENDATIONS."."

3 Page 1 of the committee report, line 18, strike "(4)" and substitute "(4);
4 and **add (5)**".

5 Page 1 of the committee report, line 19, strike "**services.**" and substitute
6 "**services - child support DRA fee cash fund.**".

7 Page 2 of the committee report, line 5, strike "threshold." and substitute
8 "threshold.

9 (5) THERE IS CREATED IN THE STATE TREASURY THE CHILD
10 SUPPORT DRA FEE CASH FUND, REFERRED TO IN THIS SUBSECTION (5) AS
11 THE "FUND". THE FUND CONSISTS OF MONEY CREDITED TO THE FUND FROM
12 THE STATE SHARE, IF ANY, OF FEES COLLECTED PURSUANT TO THIS SECTION
13 AND ANY OTHER MONEY THAT THE GENERAL ASSEMBLY MAY APPROPRIATE
14 OR TRANSFER TO THE FUND. THE STATE TREASURER SHALL CREDIT ALL
15 INTEREST AND INCOME DERIVED FROM THE DEPOSIT AND INVESTMENT OF
16 MONEY IN THE FUND TO THE FUND. SUBJECT TO ANNUAL APPROPRIATION
17 BY THE GENERAL ASSEMBLY, THE STATE DEPARTMENT MAY EXPEND
18 MONEY FROM THE FUND FOR PROGRAM OPERATIONS."."

19 Page 2 of the committee report, after line 6 insert:

20 "Page 42, strike lines 15 through 26 and substitute:

21 "**SECTION 8. Effective date - applicability.** (1) This act takes
22 effect July 1, 2019; except that section 14-10-115 (3)(c.5), (6)(b),
23 (7)(a)(II)(B), (7)(a)(II)(C), (7)(a)(II)(D), (7)(b), (8)(g), (11)(a)
24 introductory portion, (11)(a)(I), and (11)(c), Colorado Revised Statutes,
25 as amended and added in section 1 of this act, takes effect July 1, 2020.

26 (2) Section 1 of this act applies to orders entered on or after the
27 applicable effective dates specified in subsection (1) of this section.

28 **SECTION 9. Safety clause.** The general assembly hereby finds,
29 determines, and declares that this act is necessary for the immediate
30 preservation of the public peace, health, and safety.".
