HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB19-1250 be amended as follows:

1 Amend printed bill, page 6, strike lines 2 through 9 and substitute:

2 "SECTION 8. In Colorado Revised Statutes, **add** 17-18-127 as  
3 follows:

4 **17-18-127. Appropriation to comply with section 2-2-703 -**  
5 **H.B. 19-1250 - repeal.** (1) PURSUANT TO SECTION 2-2-703, THE  
6 FOLLOWING STATUTORY APPROPRIATIONS ARE MADE IN ORDER TO  
7 IMPLEMENT HOUSE BILL 19-1250, ENACTED IN 2019:

8 (a) FOR THE 2019-20 STATE FISCAL YEAR, ONE HUNDRED SEVENTY-  
9 EIGHT THOUSAND FOUR HUNDRED SEVENTY-ONE DOLLARS IS  
10 APPROPRIATED FROM THE CAPITAL CONSTRUCTION FUND CREATED IN  
11 SECTION 24-75-302, TO THE CORRECTIONS EXPANSION RESERVE FUND  
12 CREATED IN SECTION 17-1-116.

13 (b) FOR THE 2020-21 STATE FISCAL YEAR, THIRTY-NINE THOUSAND  
14 SEVEN HUNDRED ONE DOLLARS IS APPROPRIATED TO THE DEPARTMENT  
15 FROM THE GENERAL FUND.

16 (c) FOR THE 2021-22 STATE FISCAL YEAR, FORTY-THREE THOUSAND  
17 NINE HUNDRED SIXTEEN DOLLARS IS APPROPRIATED TO THE DEPARTMENT  
18 FROM THE GENERAL FUND.

19 (d) FOR THE 2022-23 STATE FISCAL YEAR, FORTY-THREE THOUSAND  
20 THREE HUNDRED ELEVEN DOLLARS IS APPROPRIATED TO THE DEPARTMENT  
21 FROM THE GENERAL FUND.

22 (e) FOR THE 2023-24 STATE FISCAL YEAR, FORTY-ONE THOUSAND  
23 FOUR HUNDRED NINETY-ONE DOLLARS IS APPROPRIATED TO THE  
24 DEPARTMENT FROM THE GENERAL FUND.

25 (2) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2024.

26 **SECTION 9.** In Colorado Revised Statutes, 24-75-302, **add**  
27 (2)(gg) as follows:

28 **24-75-302. Capital construction fund - capital assessment fees**  
29 **- calculation - information technology capital account - repeal.**

30 (2) The controller shall transfer a sum as specified in this subsection (2)  
31 from the general fund to the capital construction fund as moneys become  
32 available in the general fund during the fiscal year beginning on July 1 of  
33 the fiscal year in which the transfer is made. Transfers between funds  
34 pursuant to this subsection (2) are not appropriations subject to the  
35 limitations of section 24-75-201.1. The amounts transferred pursuant to  
36 this subsection (2) are as follows:

37 (gg) FOR THE 2019-20 FISCAL YEAR, ONE HUNDRED SEVENTY-  
38 EIGHT THOUSAND FOUR HUNDRED SEVENTY-ONE DOLLARS PURSUANT TO  
39 H.B. 19-1250, ENACTED IN 2019."

- 1 Renumber succeeding sections accordingly.
- 2 Page 1, line 101, strike "OFFICER." and substitute "OFFICER, AND, IN
- 3 CONNECTION THEREWITH, MAKING AN APPROPRIATION."
