1 Amend reengrossed bill, page 12, after line 1 insert:

2 "SECTION 4. In Colorado Revised Statutes, 25-7-105, **add** (1.5)
3 as follows:

4 **25-7-105. Duties of commission - rules - legislative declaration**
5 **- definitions - repeal.** (1.5) (a) THE COMMISSION SHALL APPOINT
6 MEMBERS TO AND CONVENE A TASK FORCE TO STUDY THE EFFECTS ON
7 RURAL COLORADO AND LOW-INCOME COMMUNITIES OF THE ABATEMENT
8 OF STATEWIDE GREENHOUSE GAS POLLUTION THAT WILL OCCUR PURSUANT
9 TO SUBSECTION (1)(e) OF THIS SECTION AS IT BECOMES EFFECTIVE ON
10 JANUARY 1, 2021. THE DIVISION SHALL PROVIDE ADMINISTRATIVE
11 SUPPORT TO THE TASK FORCE WITHIN EXISTING RESOURCES.

12 (b) (I) THE TASK FORCE CONSISTS OF REPRESENTATIVES OF RURAL
13 COLORADO AS NOMINATED BY THE COLORADO FARM BUREAU,
14 COLORADO CATTLEMEN'S ASSOCIATION, AND COLORADO COUNTIES, INC.,
15 REPRESENTATIVES OF LOW-INCOME COMMUNITIES AS NOMINATED BY THE
16 COLORADO COMMUNITY ACTION ASSOCIATION AND COLORADO
17 MUNICIPAL LEAGUE, REPRESENTATIVES OF THE BUSINESS COMMUNITY
18 NOMINATED BY THE COLORADO MINING ASSOCIATION AND THE
19 COLORADO CHAMBER OF COMMERCE, REPRESENTATIVES OF PUBLIC
20 INTEREST ENVIRONMENTAL GROUPS NOMINATED BY CONSERVATION
21 COLORADO, AND OTHER STAKEHOLDERS AS DETERMINED BY THE
22 COMMISSION.

23 (II) MEMBERS OF THE TASK FORCE ARE ENTITLED TO A PER DIEM
24 AND REIMBURSEMENT OF EXPENSES AS AUTHORIZED BY LAW.

25 (c) THE TASK FORCE SHALL BEGIN TO MEET BY AUGUST 1, 2020,
26 SHALL SELECT A CHAIR AND CO-CHAIR FROM AMONG ITS MEMBERS, SHALL
27 MEET AT LEAST EVERY TWO MONTHS, AND SHALL DELIVER A REPORT TO
28 THE COMMISSION AND THE GENERAL ASSEMBLY BY FEBRUARY 1, 2020,
29 THAT CONTAINS ITS RECOMMENDATIONS REGARDING:

30 (I) THE ANTICIPATED EFFECTS ON RURAL COLORADO AND
31 LOW-INCOME COMMUNITIES OF THE ABATEMENT OF STATEWIDE
32 GREENHOUSE GAS POLLUTION THAT WILL OCCUR PURSUANT TO
33 SUBSECTION (1)(e) OF THIS SECTION; AND

34 (II) POTENTIAL METHODS TO AVOID, MITIGATE, AND MINIMIZE ANY
35 ADVERSE IMPACTS, INCLUDING LEGISLATIVE AND REGULATORY CHANGES.

36 (d) THIS SUBSECTION (1.5) IS REPEALED, EFFECTIVE SEPTEMBER 1,
37 2021."

38 Renumber succeeding sections accordingly.

- 1 Page 12, line 2, strike "2019-20" and substitute "2020-21".
- 2 Page 12, line 10, strike "2019-20" and substitute "2020-21".
- 3 Page 12, after line 16 insert:
 - 4 **"SECTION 6. Effective date.** This act takes effect upon passage;
 - 5 except that sections 1 through 3 of this act take effect January 1, 2021."
- 6 Renumber succeeding section accordingly.
