HOUSE FLOOR AMENDMENT

Second Reading

BY REPRESENTATIVE Lontine

1 Amend printed bill, page 28, lines 25 and 26, strike "STUDENTS ON
2 JANUARY 1 OF THE YEAR IN WHICH THE ELECTION IS HELD;" and substitute
3 "STUDENTS;".

4 Page 29, lines 2 and 3, strike "STUDENTS ON JANUARY 1 OF THE YEAR IN
5 WHICH THE ELECTION IS HELD." and substitute "STUDENTS.".

6 Page 29, after line 9 insert:

7 "(III) AS USED IN THIS SUBSECTION (1)(b.5), THE NUMBER OF
8 ENROLLED STUDENTS AT A CAMPUS IS THE HIGHEST NUMBER OF ALL
9 FULL-TIME, PART-TIME, GRADUATE, AND UNDERGRADUATE STUDENTS, NOT
10 INCLUDING STUDENTS SOLELY REGISTERED FOR ONLINE COURSES AND
11 CONCURRENT ENROLLMENT STUDENTS, DURING THE FALL SEMESTER OF
12 THE YEAR OF THE PREVIOUS GENERAL ELECTION ACCORDING TO DATA
13 COLLECTED BY THE DEPARTMENT OF HIGHER EDUCATION. THE
14 DEPARTMENT OF HIGHER EDUCATION SHALL PROVIDE THE DATA TO THE
15 SECRETARY OF STATE ON OR BEFORE DECEMBER 1 OF EACH GENERAL
16 ELECTION YEAR; EXCEPT THAT, THE DEPARTMENT OF HIGHER EDUCATION
17 SHALL PROVIDE THE DATA FOR THE FALL SEMESTER OF 2018 TO THE
18 SECRETARY OF STATE ON OR BEFORE OCTOBER 1, 2019. THE SECRETARY
19 OF STATE SHALL DETERMINE FROM THE DATA WHICH CAMPUSES MEET THE
20 ENROLLMENT THRESHOLDS FOR THE NEXT GENERAL ELECTION.

21 (IV) AS USED IN THIS SUBSECTION (1)(b.5), "CAMPUS" MEANS ANY
22 COLLECTION OF BUILDINGS AND SURROUNDING GROUNDS OWNED OR USED
23 BY A STATE INSTITUTION OF HIGHER EDUCATION TO REGULARLY PROVIDE
24 STUDENTS WITH EDUCATION, HOUSING, OR COLLEGE ACTIVITIES. IF ONE OR
25 MORE STATE INSTITUTIONS OF HIGHER EDUCATION SHARE BUILDINGS OR
26 GROUNDS, OR IF THE CAMPUSES OF ONE OR MORE STATE INSTITUTIONS OF
27 HIGHER EDUCATION ARE ADJACENT OR OTHERWISE CONNECTED, THE
28 SHARED OR CONNECTED BUILDINGS AND GROUNDS CONSTITUTE A SINGLE
29 CAMPUS FOR THE PURPOSES OF THIS SUBSECTION (1)(b.5)."

30 Page 33, lines 1 and 2, strike "ON JANUARY 1 OF THE YEAR IN WHICH AN
31 ELECTION IS HELD." and substitute "AS DETERMINED IN ACCORDANCE WITH
32 SUBSECTION (1)(b.5)(III) OF THIS SECTION.".

33 Page 43, lines 18 and 19, strike "ON JANUARY 1 OF THE YEAR IN WHICH
34 THE ELECTION IS HELD." and substitute "AS DETERMINED IN ACCORDANCE
35 WITH SECTION 1-5-102.9 (1)(b.5)(III)."

1 Page 44, lines 21 and 22, strike "ON JANUARY 1 OF THE YEAR IN WHICH
2 THE ELECTION IS HELD." and substitute "AS DETERMINED IN ACCORDANCE
3 WITH SECTION 1-5-102.9 (1)(b.5)(III).".
