HB19-1308 be amended as follows:

27 IV-E PREVENTION PLAN, AT WHICH TIME THE DEPARTMENT OF HUMAN

29 COMMITTEE FOR NECESSARY FUNDING TO IMPLEMENT THE PLAN."."
