## HOUSE FLOOR AMENDMENT

Second Reading

1 Amend corrected printed bill, page 4, line 17, strike "(a)" and substitute  
2 "(a)(I)".

3 Page 4, after line 24 insert:

4 "(a) (II) A STUDENT WHO COMPLIES WITH COMPULSORY SCHOOL  
5 ATTENDANCE BY PARTICIPATING IN A NONPUBLIC HOME-BASED  
6 EDUCATIONAL PROGRAM, PURSUANT TO SECTION 22-33-104.5, OR AN  
7 INDEPENDENT SCHOOL PROVIDING A BASIC ACADEMIC EDUCATION, AS  
8 DESCRIBED IN SECTION 22-33-104 (2)(b), IS NOT REQUIRED TO COMPLY  
9 WITH SUBSECTION (1)(a)(I) OF THIS SECTION. A STUDENT MAY COMPLY  
10 WITH SECTION 22-33-104.5 (3)(g) BY MAINTAINING AN UP-TO-DATE  
11 CERTIFICATION OF IMMUNIZATION."

12 Page 6, after line 13 insert:

13 "(IV) A STUDENT WHO COMPLIES WITH COMPULSORY SCHOOL  
14 ATTENDANCE BY PARTICIPATING IN A NONPUBLIC HOME-BASED  
15 EDUCATIONAL PROGRAM, PURSUANT TO SECTION 22-33-104.5, OR AN  
16 INDEPENDENT SCHOOL PROVIDING A BASIC ACADEMIC EDUCATION, AS  
17 DESCRIBED IN SECTION 22-33-104 (2)(b), IS NOT REQUIRED TO COMPLY  
18 WITH SUBSECTIONS (2)(a)(I) TO (2)(a)(III) OF THIS SECTION. A PARENT,  
19 LEGAL GUARDIAN, OR STUDENT, MAY COMPLY WITH SECTION 22-33-104.5  
20 (3)(g) BY MAINTAINING A CERTIFICATION FROM A LICENSED PHYSICIAN,  
21 PHYSICIAN ASSISTANT, OR ADVANCED PRACTICE NURSE THAT ONE OR  
22 MORE SPECIFIED IMMUNIZATIONS WOULD ENDANGER THE STUDENT'S LIFE  
23 OR HEALTH OR IS MEDICALLY CONTRAINDICATED DUE TO OTHER MEDICAL  
24 CONDITIONS."

25 Page 8, after line 8 insert:

26 "(IV) A STUDENT WHO COMPLIES WITH COMPULSORY SCHOOL  
27 ATTENDANCE BY PARTICIPATING IN A NONPUBLIC HOME-BASED  
28 EDUCATIONAL PROGRAM, PURSUANT TO SECTION 22-33-104.5, OR AN  
29 INDEPENDENT SCHOOL PROVIDING A BASIC ACADEMIC EDUCATION, AS  
30 DESCRIBED IN SECTION 22-33-104 (2)(b), IS NOT REQUIRED TO COMPLY  
31 WITH SUBSECTIONS (2)(b)(I) TO (2)(b)(III) OF THIS SUBSECTION. A PARENT  
32 OR LEGAL GUARDIAN, OR STUDENT WHO IS EMANCIPATED OR EIGHTEEN  
33 YEARS OF AGE OR OLDER, MAY COMPLY WITH SECTION 22-33-104.5 (3)(g)  
34 BY MAINTAINING A STATEMENT OF EXEMPTION THAT THE PARENT, LEGAL  
35 GUARDIAN, OR STUDENT IS AN ADHERENT TO A RELIGIOUS BELIEF WHOSE  
36 TEACHINGS ARE OPPOSED TO IMMUNIZATIONS OR THAT THE PARENT,  
37 LEGAL GUARDIAN, OR STUDENT HAS A PERSONAL BELIEF THAT IS OPPOSED  
38 TO IMMUNIZATIONS."
