

HOUSE FLOOR AMENDMENT

Second Reading

BY REPRESENTATIVE Becker

1 Amend printed bill, page 6, line 3, strike the second "RETAIL".

2 Page 6, line 7, strike "RETAIL".

3 Page 13, line 1, strike "RETAIL" and substitute "ELECTRICITY".

4 Page 13, after line 11 insert:

5 (f) (I) A CLEAN ENERGY PLAN VOLUNTARILY FILED BY A
6 MUNICIPAL UTILITY OR A COOPERATIVE ELECTRIC ASSOCIATION THAT HAS
7 VOTED TO EXEMPT ITSELF FROM REGULATION BY THE COMMISSION
8 PURSUANT TO ARTICLE 9.5 OF THIS TITLE 40 SHALL BE DEEMED APPROVED
9 BY THE COMMISSION AS FILED IF:

10 (A) THE DIVISION OF ADMINISTRATION, IN CONSULTATION WITH
11 THE COMMISSION, VERIFIES THAT THE PLAN DEMONSTRATES THAT, BY
12 2030, THE MUNICIPAL UTILITY OR COOPERATIVE ELECTRIC ASSOCIATION
13 WILL ACHIEVE AT LEAST AN EIGHTY PERCENT REDUCTION IN GREENHOUSE
14 GAS EMISSIONS CAUSED BY THE ENTITY'S COLORADO ELECTRICITY SALES
15 RELATIVE TO 2005 LEVELS; AND

16 (B) THE CLEAN ENERGY PLAN HAS PREVIOUSLY BEEN APPROVED
17 BY A VOTE OF THE ENTITY'S GOVERNING BODY.

18 (II) VOLUNTARY SUBMISSION OF A CLEAN ENERGY PLAN BY A
19 MUNICIPAL UTILITY OR A COOPERATIVE ELECTRIC ASSOCIATION DOES NOT
20 ALTER THE ENTITY'S REGULATORY STATUS WITH RESPECT TO THE
21 COMMISSION, INCLUDING UNDER ARTICLE 9.5 OF THIS TITLE 40."
