

## HOUSE FLOOR AMENDMENT

Second Reading

1 Amend printed bill, page 24, line 5, strike "AT LEAST".

2 Page 24, strike lines 12 through 27.

3 Page 25, strike lines 1 through 3 and substitute:

4 "(2) (a) (I) THE COMMISSION MAY ISSUE A MASTER LICENSE, UPON  
5 THE APPLICANT'S PAYMENT OF ANY REQUIRED FEES AND COMPLIANCE  
6 WITH ALL OTHER REQUIREMENTS OF THIS PART 15, TO A PERSON THAT  
7 HOLDS A RETAIL GAMING LICENSE AS DESCRIBED IN SECTION 44-30-501  
8 (1)(c). A PERSON HOLDING MORE THAN ONE RETAIL GAMING LICENSE MAY  
9 BE ISSUED ONE MASTER LICENSE FOR EACH RETAIL GAMING LICENSE IT  
10 HOLDS.

11 (II) THE PURCHASE OF AN EXISTING OWNERSHIP INTEREST IN A  
12 CASINO REQUIRING THE ISSUANCE OF A NEW RETAIL GAMING LICENSE DOES  
13 NOT PROHIBIT THE TRANSFER OF AN EXISTING MASTER LICENSE WITH THE  
14 OWNERSHIP INTEREST, SUBJECT TO APPROVAL BY THE COMMISSION.

15 (III) A MASTER LICENSEE SHALL CONDUCT SPORTS BETTING ON ITS  
16 PREMISES IN ACCORDANCE WITH THIS PART 15 AND SHALL NOT TRANSFER  
17 ITS LICENSED SPORTS BETTING OPERATION TO BE CONDUCTED AT ANY  
18 FACILITY LOCATED OUTSIDE THE CITY OF CENTRAL, THE CITY OF BLACK  
19 HAWK, OR THE CITY OF CRIPPLE CREEK, REGARDLESS OF WHETHER THAT  
20 FACILITY IS LICENSED TO MANUFACTURE OR SELL ALCOHOL BEVERAGES  
21 UNDER THIS TITLE 44; LICENSED AS A CLASS B TRACK OR SIMULCAST  
22 FACILITY UNDER ARTICLE 32 OF THIS TITLE 44; LICENSED AS A LOTTERY  
23 SALES AGENT UNDER SECTION 44-40-107; OR LICENSED TO CONDUCT  
24 BINGO OR RAFFLES UNDER PART 6 OF ARTICLE 21 OF TITLE 24. THIS  
25 SUBSECTION (2)(a)(III) DOES NOT PROHIBIT SPORTS BETTING THROUGH A  
26 LICENSED INTERNET SPORTS BETTING OPERATOR BY A CUSTOMER USING  
27 HIS OR HER OWN COMPUTER OR MOBILE OR INTERACTIVE DEVICE  
28 ANYWHERE IN THE STATE.

29 (IV) A MASTER LICENSE EXPIRES TWO YEARS AFTER THE DATE OF  
30 ISSUANCE BUT MAY BE RENEWED UPON THE FILING AND APPROVAL OF AN  
31 APPLICATION FOR RENEWAL."

32 Page 26, line 7, after "(4)" insert "EACH LICENSE ISSUED PURSUANT TO  
33 THIS SECTION EXPIRES TWO YEARS AFTER ISSUANCE BUT MAY BE RENEWED  
34 UPON THE FILING AND APPROVAL OF AN APPLICATION FOR RENEWAL."

35 Page 27, line 7, strike "BETTING" and substitute "BETTING, OTHER THAN  
36 BY A CUSTOMER USING HIS OR HER OWN COMPUTER OR MOBILE OR  
37 INTERACTIVE DEVICE THROUGH AN INTERNET SPORTS BETTING  
38 OPERATION,".
