

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB19-036 be amended as follows:

1 Amend printed bill, page 3, after line 5 insert:

2 "(III) A PHONE NUMBER COLLECTED FOR THE EXPRESS PURPOSE OF  
3 ADMINISTERING THE COURT REMINDER PROGRAM PURSUANT TO THIS  
4 SECTION MUST BE KEPT SEPARATE FROM OTHER IDENTIFYING  
5 INFORMATION. SUCH PHONE NUMBER MUST ONLY BE USED TO ACHIEVE  
6 THE STATUTORY OBJECTIVE OF THE PROGRAM AS DESCRIBED IN  
7 SUBSECTION (11)(a)(I) OF THIS SECTION AND MUST NOT BE USED OR  
8 SHARED BY THE JUDICIAL DEPARTMENT FOR ANY OTHER PURPOSE."

9 Page 3, lines 8 and 9, strike "WITH THE CAPACITY TO RECEIVE TEXT  
10 MESSAGES," and substitute "WHO HAVE AGREED TO RECEIVE TEXT  
11 MESSAGES AND HAVE THE CAPACITY TO RECEIVE TEXT MESSAGES AT THE  
12 MOBILE TELEPHONE NUMBER PROVIDED. THE PROGRAM MUST USE TEXT  
13 MESSAGES".

14 Page 5, after line 15 insert:

15 "SECTION 2. In Colorado Revised Statutes, add 13-1-138 as  
16 follows:

17 **13-1-138. Notification of court reminder program.** A COURT  
18 THAT PARTICIPATES IN THE COURT REMINDER PROGRAM ESTABLISHED IN  
19 SECTION 13-3-101 (11)(a)(I) SHALL NOTIFY A CRIMINAL DEFENDANT OR  
20 JUVENILE PARTICIPANT, AS DEFINED IN SECTION 13-3-101 (11), AT EACH  
21 COURT APPEARANCE THAT THE INDIVIDUAL CAN ELECT TO PROVIDE A  
22 MOBILE TELEPHONE NUMBER THAT WILL BE USED BY THE COURT SOLELY  
23 TO PROVIDE TEXT MESSAGE REMINDERS FOR FUTURE COURT DATES AND  
24 SHALL PROVIDE THE OPPORTUNITY FOR THE INDIVIDUAL TO PROVIDE A  
25 MOBILE TELEPHONE NUMBER OR UPDATE A MOBILE TELEPHONE NUMBER  
26 FOR THAT PURPOSE.

27 **SECTION 3.** In Colorado Revised Statutes, add 16-4-105.5 as  
28 follows:

29 **16-4-105.5. Notification of court reminder program.** A PERSON  
30 RELEASED ON BOND PURSUANT TO THIS PART 1 WHO IS ORDERED TO  
31 APPEAR IN A COURT THAT PARTICIPATES IN THE COURT REMINDER  
32 PROGRAM ESTABLISHED IN SECTION 13-3-101 (11)(a)(I), AND ANY PERSON  
33 OTHERWISE ORDERED TO APPEAR IN A COURT THAT PARTICIPATES IN THE  
34 PROGRAM, MUST BE NOTIFIED THAT THE PERSON CAN ELECT TO PROVIDE  
35 A MOBILE TELEPHONE NUMBER THAT WILL BE USED BY THE COURT SOLELY  
36 TO PROVIDE TEXT MESSAGE REMINDERS FOR FUTURE COURT DATES AND  
37 MUST BE PROVIDED THE OPPORTUNITY TO PROVIDE A MOBILE TELEPHONE  
38 NUMBER OR UPDATE A MOBILE TELEPHONE NUMBER FOR THAT PURPOSE.

1           **SECTION 4.** In Colorado Revised Statutes, **add** 16-4-206 as  
2 follows:  
3           **16-4-206. Notification of court reminder program.** A PERSON  
4 RELEASED ON BOND PURSUANT TO THIS PART 2 WHO IS ORDERED TO  
5 APPEAR IN A COURT THAT PARTICIPATES IN THE COURT REMINDER  
6 PROGRAM ESTABLISHED IN SECTION 13-3-101 (11)(a)(I), AND ANY PERSON  
7 OTHERWISE ORDERED TO APPEAR IN A COURT THAT PARTICIPATES IN THE  
8 PROGRAM, MUST BE NOTIFIED THAT THE PERSON CAN ELECT TO PROVIDE  
9 A MOBILE TELEPHONE NUMBER THAT WILL BE USED BY THE COURT SOLELY  
10 TO PROVIDE TEXT MESSAGE REMINDERS FOR FUTURE COURT DATES AND  
11 MUST BE PROVIDED THE OPPORTUNITY TO PROVIDE A MOBILE TELEPHONE  
12 NUMBER OR UPDATE A MOBILE TELEPHONE NUMBER FOR THAT PURPOSE."

13           Renumber succeeding sections accordingly.

14           Page 5, lines 16 and 17, strike "**amend** (2)(b); and".

15           Page 5, strike lines 20 through 22.

16           Page 5, line 23, strike "PERSON'S" and substitute "PERSON CAN ELECT TO  
17 PROVIDE A MOBILE TELEPHONE NUMBER THAT WILL SOLELY BE USED TO  
18 PROVIDE TEXT MESSAGE REMINDERS OF FUTURE COURT DATES AND  
19 PROVIDE AN OPPORTUNITY FOR THE PERSON TO PROVIDE A MOBILE  
20 TELEPHONE NUMBER FOR THAT PURPOSE."

21           Page 5, strike lines 24 through 26.
