HOUSE FLOOR AMENDMENT

Second Reading

1 Amend reengrossed bill, page 7, after line 26 insert:

2 **"24-60-4005. Voter registration - required identification -**
3 **contingency.** (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS
4 PART 40, THE AGREEMENT AMONG THE STATES TO ELECT THE PRESIDENT
5 BY NATIONAL POPULAR VOTE IS NOT HEREBY ENACTED INTO LAW, UNLESS
6 EACH STATE THAT IS A PARTY TO THIS AGREEMENT ADOPTS A VOTER
7 IDENTIFICATION LAW THAT IS THE SAME OR SUBSTANTIALLY SIMILAR TO
8 THE POLICY AS ENACTED IN SUBSECTION (2) OF THIS SECTION.

9 (2) AN ELECTOR MAY REGISTER AND VOTE PRIOR TO AN ELECTION
10 OR ON ELECTION DAY IF THE ELECTOR:

11 (a) PROVIDES THE ELECTOR'S VALID UNITED STATES PASSPORT; A
12 LEGIBLE PHOTOCOPY OF THE PERTINENT PAGES OF THE PASSPORT,
13 IDENTIFYING THE ELECTOR AND SHOWING THE PASSPORT NUMBER; OR
14 BOTH A DOCUMENT THAT ESTABLISHES THE IDENTITY OF THE ELECTOR
15 AND A DOCUMENT THAT ESTABLISHES CITIZENSHIP OF THE ELECTOR.

16 (b) THE FOLLOWING DOCUMENTS ESTABLISH IDENTITY FOR
17 PURPOSES OF THIS SECTION: DRIVER'S LICENSE OR IDENTIFICATION CARD
18 ISSUED BY A STATE OR OUTLYING POSSESSION OF THE UNITED STATES
19 PROVIDED IT CONTAINS A PHOTOGRAPH OR INFORMATION SUCH AS NAME,
20 DATE OF BIRTH, GENDER, HEIGHT, EYE COLOR, AND ADDRESS;
21 IDENTIFICATION CARD ISSUED BY FEDERAL, STATE, OR LOCAL
22 GOVERNMENT AGENCIES OR ENTITIES PROVIDED IT CONTAINS A
23 PHOTOGRAPH OR INFORMATION SUCH AS NAME, DATE OF BIRTH, GENDER,
24 HEIGHT, EYE COLOR, AND ADDRESS; SCHOOL IDENTIFICATION CARD WITH
25 A PHOTOGRAPH; VOTER'S REGISTRATION CARD; UNITED STATES MILITARY
26 CARD OR DRAFT RECORD; MILITARY DEPENDENT'S IDENTIFICATION CARD;
27 UNITED STATES COAST GUARD MERCHANT MARINER CARD; NATIVE
28 AMERICAN TRIBAL DOCUMENT; OR A DRIVER'S LICENSE ISSUED BY A
29 CANADIAN GOVERNMENT AUTHORITY.

30 (c) THE FOLLOWING DOCUMENTS ESTABLISH CITIZENSHIP FOR
31 PURPOSES OF THIS SECTION: A SOCIAL SECURITY ACCOUNT NUMBER CARD;
32 CERTIFICATION OF REPORT OF BIRTH ISSUED BY THE UNITED STATES
33 DEPARTMENT OF STATE; ORIGINAL OR CERTIFIED COPY OF A BIRTH
34 CERTIFICATE ISSUED BY A STATE, COUNTY, MUNICIPAL AUTHORITY, OR
35 TERRITORY OF THE UNITED STATES BEARING AN OFFICIAL SEAL; NATIVE
36 AMERICAN TRIBAL DOCUMENT; OR UNITED STATES CITIZEN
37 IDENTIFICATION CARD."
