HOUSE FLOOR AMENDMENT

Second Reading

1 Amend reengrossed bill, page 16, line 8, strike "Individuals<sup>14, 14a</sup>" and  
 2 substitute "~~Individuals<sup>14, 14a</sup>~~ INDIVIDUALS<sup>14, 14a, 14b</sup>".

3 Page 16, line 9, in the TOTAL column strike "7,878,707,978" and  
 4 substitute "7,879,107,978", in the CASH FUNDS column strike  
 5 "1,061,288,833<sup>b</sup>" and substitute "1,061,488,833<sup>b</sup>", and in the FEDERAL  
 6 FUNDS column strike "4,583,112,095" and substitute "4,583,312,095".

7 Adjust affected totals accordingly.

8 Page 17, line 10, strike "\$500,000" and substitute "~~\$500,000~~ \$700,000".

9 Page 35, after line 15 insert:

10 "14b DEPARTMENT OF HEALTH CARE POLICY AND FINANCING, MEDICAL  
 11 SERVICES PREMIUMS, MEDICAL AND LONG-TERM CARE SERVICES  
 12 FOR MEDICAID ELIGIBLE INDIVIDUALS -- THIS LINE ITEM INCLUDES  
 13 \$400,000 TOTAL FUNDS, COMPOSED OF \$200,000 CASH FUNDS  
 14 FROM AN INTERGOVERNMENTAL TRANSFER FROM DENVER HEALTH  
 15 AND \$200,000 FEDERAL FUNDS, FOR THE PURPOSE OF INCREASING  
 16 NURSING HOME SERVICES FOR CHRONICALLY ACUTE, LONG-STAY  
 17 PATIENTS."

**PURPOSE:** Adds \$400,000 total funds to the Department of **Health Care Policy and Financing**, including \$200,000 cash funds from an intergovernmental transfer from Denver Health and \$200,000 federal funds, and adds a footnote explaining the purpose is to increase nursing home services for chronically acute, long-stay patients.

In addition, the amendment increases the General Fund obligation for a TABOR refund by \$200,000. This occurs because the revenue from the intergovernmental transfer is subject to the TABOR limit and both the Legislative Council Staff and Office of State Planning and Budgeting December revenue forecasts project a refund obligation in FY 2018-19.
