Committee on Education.

SB19-176 be amended as follows:

1 Amend reengrossed bill, page 18, after line 15 insert:

2 "SECTION 8. In Colorado Revised Statutes, 22-54-103, **amend**  
3 (10)(a)(I); and **add** (10)(h) as follows:

4 **22-54-103. Definitions.** As used in this article 54, unless the  
5 context otherwise requires:

6 (10) (a) (I) "Pupil enrollment" means the number of pupils  
7 enrolled on the pupil enrollment count day within the applicable budget  
8 year, as evidenced by the actual attendance of such pupils prior to said  
9 date, except as otherwise provided in ~~subparagraph (II) of this paragraph~~  
10 ~~(a)~~ SUBSECTIONS (10)(a)(II) AND (10)(h) OF THIS SECTION, plus the  
11 number of pupils expelled prior to the pupil enrollment count day within  
12 the applicable budget year who are receiving educational services  
13 pursuant to section 22-33-203 as of the pupil enrollment count day of the  
14 applicable budget year.

15 (h) (I) FOR THE 2019-20 BUDGET YEAR AND EACH BUDGET YEAR  
16 THEREAFTER, WITH REGARD TO A PUPIL WHO IS SIMULTANEOUSLY  
17 ENROLLED IN A DISTRICT OR INSTITUTE CHARTER SCHOOL AND IN ONE OR  
18 MORE POSTSECONDARY COURSES, A DISTRICT OR INSTITUTE CHARTER  
19 SCHOOL MUST SUBMIT EVIDENCE OF:

20 (A) ENROLLMENT IN THE DISTRICT OR INSTITUTE CHARTER SCHOOL  
21 AND EVIDENCE, AS PROVIDED IN STATE BOARD RULE, OF ATTENDANCE FOR  
22 ANY SECONDARY COURSES THE PUPIL IS ENROLLED IN; AND

23 (B) ENROLLMENT IN ONE OR MORE POSTSECONDARY COURSES, BY  
24 SUBMITTING EVIDENCE, AS DESCRIBED IN STATE BOARD RULE, ONLY OF  
25 THE DISTRICT'S OR INSTITUTE CHARTER SCHOOL'S NONREFUNDABLE  
26 OBLIGATION TO PAY THE STUDENT SHARE OF TUITION FOR THE  
27 POSTSECONDARY COURSE ON BEHALF OF THE PUPIL.

28 (II) THE STATE BOARD BY RULE SHALL SPECIFY THE NUMBER OF  
29 SECONDARY AND POSTSECONDARY COURSE CREDIT HOURS THAT  
30 CONSTITUTE FULL-TIME AND PART-TIME MEMBERSHIP."

31 Renumber succeeding sections accordingly.
