<u>PURPOSE</u>: Appropriates \$7,210,963 General Fund to the Department of **Education** for special education programs for children with disabilities. Reduces General Fund appropriations to the **Judicial Department** by \$7,210,963, comprised of reductions of \$2.0 million to the state courts and \$5.2 million to the Office of the State Public Defender. The reduced appropriation to the state courts would pay for courthouse furnishings and infrastructure maintenance; the reduced appropriation to the Office of the State Public Defender would pay for a 10.0 percent salary increase for the Office's attorneys and 1.5 FTE who would staff courtrooms in Denver County and Arapahoe County.
