

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

SB19-218 be amended as follows:

1 Amend printed bill, page 2, line 3, after "(2)(a.5)(II)," insert "(2)(c)", and
2 after "(3.5)(d)" insert "(5)(a)".

3 Page 2, line 4, after "**add**" insert "(2)(d.4) and".

4 Page 3, after line 1 insert:

5 "(c) "In good standing", with respect to a physician's OR MEDICAL
6 PROFESSIONAL'S license, means:

7 (I) The physician holds a doctor of medicine or doctor of
8 osteopathic medicine degree from an accredited medical school, OR THE
9 MEDICAL PROFESSIONAL HOLDS A DEGREE IN A MEDICAL FIELD WITHIN HIS
10 OR HER SCOPE OF PRACTICE;

11 (II) The physician holds a valid license to practice medicine, OR
12 THE MEDICAL PROFESSIONAL HOLDS A VALID LICENSE TO PRACTICE WITHIN
13 HIS OR HER SCOPE OF PRACTICE, in Colorado that does not contain a
14 restriction or condition that prohibits the recommendation of medical
15 marijuana or for a license issued prior to July 1, 2011, a valid,
16 unrestricted and unconditioned license; and

17 (III) The physician OR MEDICAL PROFESSIONAL has a valid and
18 unrestricted United States department of justice federal drug enforcement
19 administration controlled substances registration.

20 (d.4) "PHYSICIAN", WHEN MAKING MEDICAL MARIJUANA
21 RECOMMENDATIONS FOR A DISABLING MEDICAL CONDITION, INCLUDES A
22 MEDICAL PROFESSIONAL WITH PRESCRIPTIVE AUTHORITY ACTING WITHIN
23 THE SCOPE OF HIS OR HER PRACTICE."

24 Page 4, after line 15 insert:

25 "(a) The physician ~~shall have~~ HAS a valid and active license to
26 practice medicine, which license is in good standing, OR THE MEDICAL
27 PROFESSIONAL HOLDS A VALID LICENSE TO PRACTICE WITHIN HIS OR HER
28 SCOPE OF PRACTICE, WHICH LICENSE IS IN GOOD STANDING."

29 Page 4, strike line 23, and substitute "RECOMMENDATION; EXCEPT WHEN
30 MAKING A MEDICAL MARIJUANA RECOMMENDATION FOR A PATIENT WITH
31 A DISABLING MEDICAL CONDITION, THE RECOMMENDATION MAY BE MADE
32 BY A MEDICAL PROFESSIONAL WITH PRESCRIPTIVE AUTHORITY ACTING
33 WITHIN THE SCOPE OF HIS OR HER PRACTICE."
