

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

SB19-224 be amended as follows:

1 Amend printed bill, page 29, after line 9, insert:

2 "(V) A REQUIREMENT THAT EVERY MEDICAL MARIJUANA CENTER  
3 POST, AT ALL TIMES AND IN A PROMINENT PLACE, A WARNING THAT HAS A  
4 MINIMUM HEIGHT OF THREE INCHES AND A WIDTH OF SIX INCHES AND THAT  
5 READS:

6 **WARNING:** USING MARIJUANA, IN ANY FORM, WHILE YOU  
7 ARE PREGNANT OR BREASTFEEDING PASSES THC TO YOUR  
8 BABY AND MAY BE HARMFUL TO YOUR BABY. THERE IS NO  
9 KNOWN SAFE AMOUNT OF MARIJUANA USE DURING  
10 PREGNANCY OR BREASTFEEDING."

11 Page 47, after line 12, insert:

12 "(i) A REQUIREMENT THAT EVERY RETAIL MARIJUANA STORE POST,  
13 AT ALL TIMES AND IN A PROMINENT PLACE, A WARNING THAT HAS A  
14 MINIMUM HEIGHT OF THREE INCHES AND A WIDTH OF SIX INCHES AND THAT  
15 READS:

16 **WARNING:** USING MARIJUANA, IN ANY FORM, WHILE YOU  
17 ARE PREGNANT OR BREASTFEEDING PASSES THC TO YOUR  
18 BABY AND MAY BE HARMFUL TO YOUR BABY. THERE IS NO  
19 KNOWN SAFE AMOUNT OF MARIJUANA USE DURING  
20 PREGNANCY OR BREASTFEEDING."

21 Page 137, after line 14, insert:

22 "(h) A REQUIREMENT THAT EVERY MEDICAL MARIJUANA STORE  
23 AND RETAIL MARIJUANA STORE POST, AT ALL TIMES AND IN A PROMINENT  
24 PLACE, A WARNING THAT HAS A MINIMUM HEIGHT OF THREE INCHES AND  
25 A WIDTH OF SIX INCHES AND THAT READS:

26 **WARNING:** USING MARIJUANA, IN ANY FORM, WHILE YOU  
27 ARE PREGNANT OR BREASTFEEDING PASSES THC TO YOUR  
28 BABY AND MAY BE HARMFUL TO YOUR BABY. THERE IS NO  
29 KNOWN SAFE AMOUNT OF MARIJUANA USE DURING  
30 PREGNANCY OR BREASTFEEDING."
