- 23 SECTION.".
- Page 128, strike lines 14 through 18 and substitute:
- 25 "(c) Accelerator manufacturer licensee if the retail
- 26 MARIJUANA PRODUCTS MANUFACTURER HAS ITS PREMISES ENDORSED
- 27 PURSUANT TO RULE BEFORE EACH ACCELERATOR MANUFACTURER
- 28 LICENSEE OPERATES AND EACH ACCELERATOR LICENSEE IS LICENSED TO
- OPERATE ON THAT PREMISES.".
