

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

SB19-224 be amended as follows:

1 Amend reengrossed bill, page 12, after line 11 insert:

2 "(25) "MARIJUANA CONSUMER WASTE" MEANS ANY COMPONENT  
3 LEFT AFTER THE CONSUMPTION OF A REGULATED MARIJUANA PRODUCT,  
4 INCLUDING BUT NOT LIMITED TO CONTAINERS, PACKAGES, CARTRIDGES,  
5 PODS, CUPS, BATTERIES, ALL-IN-ONE DISPOSABLE DEVICES, AND ANY  
6 OTHER WASTE COMPONENT LEFT AFTER THE REGULATED MARIJUANA IS  
7 CONSUMED AS DEFINED BY RULES PROMULGATED BY THE STATE LICENSING  
8 AUTHORITY."

9 Renumber succeeding subsections accordingly.

10 Page 45, strike lines 1 through 10 and substitute:

11 "(bb) CONDITIONS UNDER WHICH A LICENSEE IS AUTHORIZED TO  
12 COLLECT MARIJUANA CONSUMER WASTE AND TRANSFER IT TO A PERSON  
13 FOR THE PURPOSES OF REUSE OR RECYCLING IN ACCORDANCE WITH ALL  
14 REQUIREMENTS ESTABLISHED BY THE DEPARTMENT OF PUBLIC HEALTH  
15 AND ENVIRONMENT PERTAINING TO WASTE DISPOSAL AND RECYCLING. THE  
16 CONDITIONS MUST INCLUDE:

17 (I) THAT THE PERSON RECEIVING MARIJUANA CONSUMER WASTE  
18 FROM A LICENSEE IS, TO THE EXTENT REQUIRED BY LAW, REGISTERED WITH  
19 THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT;

20 (II) RECORD-KEEPING REQUIREMENTS;

21 (III) SECURITY MEASURES RELATED TO THE COLLECTION AND  
22 TRANSFER OF MARIJUANA CONSUMER WASTE;

23 (IV) HEALTH AND SAFETY REQUIREMENTS, INCLUDING  
24 REQUIREMENTS FOR THE HANDLING OF MARIJUANA CONSUMER WASTE;  
25 AND

26 (V) PROCESSES ASSOCIATED WITH HANDLING MARIJUANA  
27 CONSUMER WASTE, INCLUDING DESTRUCTION OF ANY REMAINING  
28 REGULATED MARIJUANA IN THE MARIJUANA CONSUMER WASTE."

29 Page 160, line 4, strike "(26)" and substitute "(27)".

30 Page 160, line 5, strike "(45);" and substitute "(46);".

31 Page 162, line 7, strike "(26)" and substitute "(27)".

32 Page 162, line 8, strike "(45)." and substitute "(46).".

33 Page 171, line 21, strike "(53)," and substitute "(54),".

34 Page 174, line 15, strike "(26)." and substitute "(27).".
