

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

SB19-228 be amended as follows:

1 Amend printed bill, page 20, strike lines 15 through 27.

2 Strike page 21.

3 Page 22, strike lines 1 through 8 and substitute:

4 **"(2) Perinatal substance use data linkage project.** (a) THE
5 CENTER FOR RESEARCH INTO SUBSTANCE USE DISORDER PREVENTION,
6 TREATMENT, AND RECOVERY SUPPORT STRATEGIES ESTABLISHED IN
7 SECTION 27-80-118, REFERRED TO IN THIS SECTION AS THE "CENTER", IN
8 PARTNERSHIP WITH THE UNIVERSITY OF DENVER AND THE STATE
9 SUBSTANCE ABUSE TREND AND RESPONSE TASK FORCE ESTABLISHED IN
10 SECTION 18-18.5-103, SHALL CONDUCT A STATEWIDE PERINATAL
11 SUBSTANCE USE DATA LINKAGE PROJECT THAT USES ONGOING
12 COLLECTION, ANALYSIS, INTERPRETATION, AND DISSEMINATION OF DATA
13 FOR THE PLANNING, IMPLEMENTATION, AND EVALUATION OF PUBLIC
14 HEALTH ACTIONS TO IMPROVE OUTCOMES FOR FAMILIES IMPACTED BY
15 SUBSTANCE USE DURING PREGNANCY. THE DATA LINKAGE PROJECT SHALL
16 CONSIDER STATE ADMINISTERED DATA SOURCES THAT INCLUDE:

17 (I) HEALTH CARE UTILIZATION BY PREGNANT AND POSTPARTUM
18 WOMEN WITH SUBSTANCE USE DISORDERS AND THEIR INFANTS;

19 (II) HUMAN SERVICES AND PUBLIC HEALTH PROGRAM UTILIZATION
20 BY PREGNANT AND POSTPARTUM WOMEN WITH SUBSTANCE USE DISORDERS
21 AND THEIR INFANTS;

22 (III) HEALTH CARE, HUMAN SERVICES, AND PUBLIC HEALTH
23 PROGRAM OUTCOMES AMONG PREGNANT AND POSTPARTUM WOMEN WITH
24 SUBSTANCE USE DISORDERS AND THEIR INFANTS; AND

25 (IV) COSTS ASSOCIATED WITH HEALTH CARE, HUMAN SERVICES,
26 AND PUBLIC HEALTH PROGRAM PROVISIONS FOR PREGNANT AND
27 POSTPARTUM WOMEN WITH SUBSTANCE USE DISORDERS AND THEIR
28 INFANTS.

29 (b) THE DATA LINKAGE PROJECT SHALL USE VITAL RECORDS TO
30 ESTABLISH MATERNAL AND INFANT DYADS BEGINNING AT THE BIRTH
31 HOSPITALIZATION AND RETROSPECTIVELY LINK THE PRENATAL PERIOD
32 AND PROSPECTIVELY LINK THE FIRST YEAR POSTPARTUM.

33 (c) THE LINKED INFORMATION NETWORK OF COLORADO IN THE
34 COLORADO GOVERNOR'S OFFICE OF INFORMATION TECHNOLOGY WILL
35 OBTAIN DATA THROUGH THE LINKED INFORMATION NETWORK OF
36 COLORADO GOVERNANCE PROCESS AND PERFORM SECURE LINKAGE AND
37 ANONYMIZATION ON BEHALF OF COLORADO.

38 (d) THE CENTER SHALL REPORT TO THE HEALTH AND INSURANCE

1 AND THE PUBLIC HEALTH CARE AND HUMAN SERVICES COMMITTEES OF THE
2 HOUSE OF REPRESENTATIVES AND THE HEALTH AND HUMAN SERVICES
3 COMMITTEE OF THE SENATE, OR THEIR SUCCESSOR COMMITTEES:
4 (I) THE PRELIMINARY RESULTS OF THE DATA LINKAGE PROJECT ON
5 OR BEFORE JANUARY 1, 2021, AND;
6 (II) THE FINAL RESULTS OF THE DATA LINKAGE PROJECT ON OR
7 BEFORE JULY 1, 2022.
8 (e) FOR THE FISCAL YEARS 2019-20, 2020-21 AND 2021-22, THE
9 GENERAL ASSEMBLY SHALL APPROPRIATE ONE HUNDRED THOUSAND
10 DOLLARS TO THE STATE DEPARTMENT FOR ALLOCATION TO THE CENTER
11 FOR THE PURPOSES OF THIS SUBSECTION (2)."
