Second Reading

1 Amend printed bill, page 4, strike lines 2 through 13.

2 Strike pages 5 through 7.

3 Page 8, strike lines 1 through 8.

4 Renumber succeeding sections accordingly.

5 Page 18, line 16, strike "and (25)(a)(XXII)" and substitute "(25)(a)(XXII),  
6 and (25)(a)(XXIII)".

7 Page 18, after line 20 insert:

8 "(XX) THE COMPETENCY REQUIREMENTS CREATED BY RULE OF  
9 THE APPLICABLE LICENSING BOARDS PURSUANT TO SECTION 12-30-111;".

10 Renumber succeeding subparagraphs accordingly.

11 Page 29, strike lines 3 through 27.

12 Strike pages 30 and 31.

13 Page 32, strike lines 1 through 21 and substitute:

14 "SECTION 11. In Colorado Revised Statutes, **add to article 30**  
15 **as relocated by House Bill 19-1172** 12-30-111 as follows:

16 **12-30-111. Demonstrated competency - opiate prescribers -**  
17 **rules - definition - repeal.** (1) (a) THE APPLICABLE LICENSING BOARD  
18 FOR EACH LICENSED HEALTH CARE PROVIDER SHALL PROMULGATE RULES  
19 THAT REQUIRE EACH LICENSED HEALTH CARE PROVIDER, AS A CONDITION  
20 OF RENEWING, REACTIVATING, OR REINSTATING A LICENSE ON OR AFTER  
21 OCTOBER 1, 2019, TO COMPLETE UP TO FOUR CREDIT HOURS OF TRAINING  
22 PER LICENSING CYCLE IN ORDER TO DEMONSTRATE COMPETENCY  
23 REGARDING: BEST PRACTICES FOR OPIOID PRESCRIBING, ACCORDING TO  
24 THE MOST RECENT VERSION OF THE DIVISION'S GUIDELINES FOR THE SAFE  
25 PRESCRIBING AND DISPENSING OF OPIOIDS; RECOGNITION OF SUBSTANCE  
26 USE DISORDERS; REFERRAL OF PATIENTS WITH SUBSTANCE USE DISORDERS  
27 FOR TREATMENT; AND THE USE OF THE ELECTRONIC PRESCRIPTION DRUG  
28 MONITORING PROGRAM CREATED IN PART 4 OF ARTICLE 280 OF THIS TITLE  
29 12.

1 (b) THE RULES PROMULGATED BY EACH BOARD SHALL EXEMPT A  
2 LICENSED HEALTH CARE PROVIDER WHO:

3 (I) MAINTAINS A NATIONAL BOARD CERTIFICATION THAT REQUIRES  
4 EQUIVALENT SUBSTANCE USE PREVENTION TRAINING; OR

5 (II) ATTESTS TO THE APPROPRIATE BOARD THAT THE HEALTH CARE  
6 PROVIDER DOES NOT PRESCRIBE OPIOIDS.

7 (2) FOR THE PURPOSES OF THIS SECTION, "LICENSED HEALTH CARE  
8 PROVIDER" INCLUDES A PHYSICIAN, PHYSICIAN ASSISTANT, PODIATRIST,  
9 DENTIST, ADVANCED PRACTICE NURSE WITH PRESCRIPTIVE AUTHORITY,  
10 OPTOMETRIST, AND VETERINARIAN LICENSED PURSUANT TO THIS TITLE 12.

11 (3) THIS SECTION IS REPEALED, EFFECTIVE SEPTEMBER 1, 2024.  
12 BEFORE THE REPEAL, THIS SECTION IS SCHEDULED FOR REVIEW IN  
13 ACCORDANCE WITH SECTION 24-34-104."

14 Renumber succeeding sections accordingly.

15 Strike "sections 16 through 23" and substitute "section 11" on: **Page 34**,  
16 lines 3 and 4 and 5.
