

## SENATE FLOOR AMENDMENT

Second Reading

1 Amend the State, Veterans, & Military Affairs Committee Report, dated  
2 April 10, 2019, page 1, strike lines 1 through 4 and substitute:

3 "Amend printed bill, page 2, strike lines 5 through 7 and substitute  
4 **"department of revenue.** (1) (a) IN ADDITION TO THE REQUIREMENTS OF  
5 SECTION 1-2-213 FOR REGISTERED ELECTORS, THE DEPARTMENT OF  
6 REVENUE SHALL PROVIDE TO THE SECRETARY OF STATE, ON A SCHEDULE  
7 ESTABLISHED BY THE SECRETARY OF STATE, ELECTRONIC RECORDS  
8 CONTAINING THE FULL NAME, DATE OF BIRTH, RESIDENCE ADDRESS,  
9 DELIVERABLE MAILING ADDRESS IF DIFFERENT FROM THE RESIDENCE  
10 ADDRESS, COUNTY OF RESIDENCE, CITIZENSHIP INFORMATION FOR, AND AN  
11 ELECTRONIC COPY OF THE SIGNATURE OF EACH UNREGISTERED ELECTOR  
12 AND EACH PERSON ELIGIBLE TO PREREGISTER IN ACCORDANCE WITH  
13 SECTION 1-2-101 (2) WHO PROVIDES A DOCUMENT THAT DEMONSTRATES  
14 UNITED STATES CITIZENSHIP AND WHO APPLIES FOR THE ISSUANCE,  
15 RENEWAL, OR CORRECTION OF ANY TYPE OF DRIVER'S LICENSE OR  
16 IDENTIFICATION CARD PURSUANT TO PART 3 OF ARTICLE 2 OF TITLE 42;  
17 EXCEPT THAT THE DEPARTMENT OF STATE SHALL NOT USE THE RECORD OF  
18 AN INDIVIDUAL WHO APPLIES FOR OR RENEWS AN IDENTIFICATION  
19 DOCUMENT UNDER PART 5 OF ARTICLE 2 OF TITLE 42 OR THE RECORD OF A  
20 PERSON WHO IS A PROGRAM PARTICIPANT IN THE "ADDRESS  
21 CONFIDENTIALITY PROGRAM ACT", PART 21 OF ARTICLE 30 OF TITLE 24,  
22 FOR VOTER REGISTRATION PURPOSES.

23 (b) THE DEPARTMENT OF REVENUE SHALL CONTINUE TO OFFER ANY  
24 PERSON NOT REGISTERED TO VOTE PURSUANT TO SUBSECTION (2) OF THIS  
25 SECTION AN OPPORTUNITY TO REGISTER TO VOTE PURSUANT TO SECTION  
26 1-2-213, UNLESS THEY HAVE PROVIDED DOCUMENTATION  
27 DEMONSTRATING A LACK OF UNITED STATES CITIZENSHIP."

28 Page 3 of the bill, strike lines 1 through 11.

29 Page 3 of the bill, strike line 12 and substitute:

30 "(2) UPON RECEIVING AN ELECTRONIC RECORD FOR AN INDIVIDUAL  
31 WHO PROVIDED DOCUMENTATION THAT CONFIRMED HIS OR HER  
32 CITIZENSHIP AND CONTAINS THE MINIMUM INFORMATION TO REGISTER THE  
33 INDIVIDUAL TO VOTE, THE SECRETARY OF"

34 Page 3 of the bill, line 16, strike "If".

35 Page 3 of the bill, strike lines 17 through 27.

1 Page 4 of the bill, strike line 1.

2 Page 4 of the bill, after line 16 insert:

3           "(4) IF THE RECORD IS NOT COMPLETE, THE COUNTY CLERK AND  
4 RECORDER SHALL SEND TO THE PERSON'S ADDRESS OF RECORD, BY  
5 NONFORWARDABLE MAIL, NOTICE THAT THE PERSON HAS NOT BEEN  
6 REGISTERED OR PREREGISTERED TO VOTE AND STATING THE ADDITIONAL  
7 INFORMATION REQUIRED TO REGISTER OR PREREGISTER. IF THE PERSON  
8 PROVIDES THE ADDITIONAL INFORMATION, THE PERSON IS REGISTERED OR  
9 PREREGISTERED TO VOTE EFFECTIVE AS OF THE DATE OF THE PERSON'S  
10 APPLICATION WITH THE DEPARTMENT OF REVENUE. IF THE PERSON DOES  
11 NOT PROVIDE THE ADDITIONAL INFORMATION NECESSARY TO MAKE HIS OR  
12 HER APPLICATION COMPLETE AND ACCURATE WITHIN TWENTY-FOUR  
13 MONTHS AFTER THE NOTIFICATION IS MAILED PURSUANT TO THIS  
14 SUBSECTION (4), THE PERSON'S REGISTRATION IS CANCELLED."

15 Renumber succeeding subsections accordingly.

16 Page 5 of the bill, line 11, strike "(6)(a)(I)" and substitute "(7)(a)(I)".

17 Page 1 of the report, after line 9 insert:

18 "Page 8 of the bill, line 24, strike "25.5-4-103 (13)." and substitute  
19 "25.5-4-103 (13); EXCEPT THAT THE DEPARTMENT OF STATE SHALL NOT  
20 USE THE RECORD OF A PERSON WHO IS A PROGRAM PARTICIPANT IN THE  
21 "ADDRESS CONFIDENTIALITY PROGRAM ACT", PART 21 OF ARTICLE 30 OF  
22 TITLE 24, FOR VOTER REGISTRATION PURPOSES."."
