- Page 4, line 11, strike "AND AT LEAST ONE OPIOID ANTAGONIST".
- Page 4, line 13, strike "DISORDER" and substitute "DISORDER. THE FACILITY
- 27 SHALL DIAGNOSE AND BEGIN PROCURING THE OPIOID AGONIST AS SOON AS
- 28 PRACTICABLE, BUT NO LATER THAN THREE DAYS AFTER THE PERSON IS
- 29 COMMITTED TO OR PLACED WITH THE FACILITY. THE FACILITY SHALL
- 30 MAINTAIN THE TREATMENT OF THE PERSON".

- 32 MEDICALLY NECESSARY. THE PERSON MAY TRANSITION FROM AN OPIOID
- 33 AGONIST TO AN OPIOID ANTAGONIST IF A MEDICAL PROFESSIONAL
- 34 DETERMINES SUCH A TRANSITION IS MEDICALLY APPROPRIATE.".".
