HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Local Government.

HB20-1151 be amended as follows:

1 Amend printed bill, page 2, line 14, strike "AUTHORITY," and substitute
2 "AUTHORITY, AS MAY BE CHANGED IN THE MANNER PROVIDED IN SECTION
3 43-4-605 (2),".

4 Page 2, line 20, strike "43-4-622." and substitute "43-4-622, AS MAY BE
5 CHANGED IN THE MANNER PROVIDED IN SECTION 43-4-605 (2).".

6 Page 4, line 19, after "AUTHORITY." insert "A TRANSPORTATION PLANNING
7 ORGANIZATION ADOPTING A RESOLUTION AUTHORIZING IT TO EXERCISE
8 THE POWERS OF AN AUTHORITY SHALL ALSO PROVIDE A COPY OF THE
9 RESOLUTION FOR COMMENT TO ANY EXISTING AUTHORITY THAT INCLUDES
10 OR BORDERS ANY OF THE TERRITORY IN WHICH THE TRANSPORTATION
11 PLANNING ORGANIZATION WILL EXERCISE THE POWERS OF AN
12 AUTHORITY.".

13 Page 5, line 12, strike "or" and substitute "or".

14 Page 5, line 14, strike "4" and substitute "4, OR, WITH RESPECT TO A
15 RESOLUTION ONLY, AN EXISTING AUTHORITY,".

16 Page 5, line 27, after "authority," insert "THE EXISTING AUTHORITY,".

17 Page 7, line 11, after "ORGANIZATION," insert "MAY NOT INCLUDE
18 TERRITORY WITHIN THE BOUNDARIES OF AN EXISTING AUTHORITY
19 WITHOUT THE APPROVAL OF THE EXISTING AUTHORITY AS PROVIDED IN
20 SECTION 43-4-622 (4),".

21 Page 16, after line 25, insert:

22 "(4) NOTWITHSTANDING ANY PROVISION OF THIS PART 6 TO THE
23 CONTRARY, A TRANSPORTATION PLANNING ORGANIZATION MAY NOT
24 EXERCISE ANY OF THE POWERS OF AN AUTHORITY WITHIN THE BOUNDARIES
25 OF AN EXISTING AUTHORITY WITHOUT THE PRIOR APPROVAL OF THE BOARD
26 OF THE EXISTING AUTHORITY BY ADOPTION OF A RESOLUTION BY THE
27 AFFIRMATIVE VOTE OF TWO-THIRDS OF THE DIRECTORS OF THE
28 BOARD. THE BOARD OF THE EXISTING AUTHORITY SHALL FILE ANY SUCH
29 RESOLUTION ADOPTED WITH THE DIRECTOR OF THE DIVISION. THE
30 DIRECTOR OF THE DIVISION SHALL NOT ISSUE THE CERTIFICATE REQUIRED
31 BY SECTION 43-4-603 (1) TO A TRANSPORTATION PLANNING
32 ORGANIZATION, IF THE TRANSPORTATION PLANNING ORGANIZATION IS
33 ATTEMPTING TO EXERCISE THE POWERS OF AN AUTHORITY WITHIN THE

1 BOUNDARIES OF AN EXISTING AUTHORITY WITHOUT THE EXISTING
2 AUTHORITY'S DULY ADOPTED AND FILED RESOLUTION OF APPROVAL."
