

## SENATE FLOOR AMENDMENT

Second Reading

BY SENATORS Garcia and Pettersen

1 Amend reengrossed bill, page 27, after line 6 insert:

2 **"24-50-1117. Implementation and administration - costs.**  
3 COSTS ASSOCIATED WITH THE IMPLEMENTATION OR ADMINISTRATION OF  
4 THIS PART 11 DURING THE 2020-21 AND 2020-22 STATE FISCAL YEARS  
5 SHALL BE PAID FROM THE COVID HEROES COLLABORATION FUND,  
6 CREATED IN SECTION 24-50-104 (1)(k). FOR THE 2022-23 STATE FISCAL  
7 YEAR AND EACH STATE FISCAL YEAR THEREAFTER, SUCH COSTS SHALL BE  
8 PAID FROM THE GENERAL FUND, SUBJECT TO AVAILABLE APPROPRIATION."

9 Page 27, line 8, strike "and **repeal** (1)(j)(VI)" and substitute "**repeal**  
10 (1)(j)(VI); and **add** (1)(j)(III)(D) and (1)(k)".

11 Page 28, after line 7 insert:

12 "(D) ON THE EFFECTIVE DATE OF THIS SUBSECTION (1)(j)(III)(D),  
13 THE STATE TREASURER SHALL TRANSFER SEVEN MILLION DOLLARS FROM  
14 THE FUND TO THE COVID HEROES COLLABORATION FUND CREATED IN  
15 SUBSECTION (1)(k) OF THIS SECTION."

16 Page 28, after line 19 insert:

17 "(k) THE COVID HEROES COLLABORATION FUND IS HEREBY  
18 CREATED IN THE STATE TREASURY. THE FUND CONSISTS OF MONEY  
19 TRANSFERRED TO THE FUND PURSUANT TO SECTION 24-50-104  
20 (1)(j)(III)(D), AND ANY OTHER MONEY THAT THE GENERAL ASSEMBLY  
21 MAY APPROPRIATE OR TRANSFER TO THE FUND. THE STATE TREASURER  
22 SHALL CREDIT ALL INTEREST AND INCOME DERIVED FROM THE DEPOSIT  
23 AND INVESTMENT OF MONEY IN THE FUND TO THE FUND. ANY  
24 UNEXPENDED AND UNENCUMBERED MONEY REMAINING IN THE FUND AT  
25 THE END OF A FISCAL YEAR SHALL REMAIN IN THE FUND. SUBJECT TO  
26 ANNUAL APPROPRIATION BY THE GENERAL ASSEMBLY, APPLICABLE STATE  
27 AGENCIES MAY EXPENDED MONEY FROM THE FUND FOR THE PURPOSES OF  
28 THE "COLORADO PARTNERSHIP FOR QUALITY JOBS AND SERVICES ACT",  
29 CREATED IN PART 11 OF THIS ARTICLE 50."

30 Page 35, strike line 14.

31 Renumber succeeding section accordingly.
