HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB20-1155 be amended as follows:

1 Amend printed bill, page 3, line 15, strike "HEATER" and substitute
2 "HEATER, ELECTRIC BOILER,".

3 Page 3, after line 15 insert:

4 "(c) A PERSON THAT BUILDS A NEW RESIDENCE FOR WHICH A
5 BUYER IS UNDER CONTRACT SHALL OFFER THE BUYER PRICING, ENERGY
6 EFFICIENCY, AND UTILITY BILL INFORMATION FOR EACH NATURAL GAS,
7 ELECTRIC, OR OTHER OPTION AVAILABLE FROM AND INFORMATION
8 PERTAINING TO THOSE OPTIONS FROM THE FEDERAL ENERGY STAR
9 PROGRAM, AS DEFINED IN SECTION 6-7.5-102 (15), OR SIMILAR
10 INFORMATION ABOUT ENERGY EFFICIENCY AND UTILIZATION REASONABLY
11 AVAILABLE TO THE PERSON BUILDING THE RESIDENCE.

12 (d) SUBSECTION (1)(a) OF THIS SECTION DOES NOT APPLY TO A
13 RESIDENCE IN WHICH THE ELECTRICAL SYSTEM HAS BEEN SUBSTANTIALLY
14 INSTALLED BEFORE A BUYER ENTERS INTO A CONTRACT TO PURCHASE THE
15 RESIDENCE. SUBSECTION (1)(b) OF THIS SECTION DOES NOT APPLY TO A
16 RESIDENCE IN WHICH THE HEATING SYSTEM HAS BEEN SUBSTANTIALLY
17 INSTALLED BEFORE A BUYER ENTERS INTO A CONTRACT TO PURCHASE THE
18 RESIDENCE.".

19 Page 4, strike lines 18 through 23 and substitute:

20 "(II) AN INDUCTIVE RESIDENTIAL CHARGING SYSTEM FOR
21 BATTERY-POWERED ELECTRIC VEHICLES THAT IS CERTIFIED BY
22 UNDERWRITERS LABORATORIES AND COMPLIES WITH THE CURRENT
23 VERSION OF ARTICLE 625 OF THE NATIONAL ELECTRICAL CODE,
24 PUBLISHED BY THE NATIONAL FIRE PROTECTION ASSOCIATION, AND
25 OTHER APPLICABLE INDUSTRY STANDARDS.

26 (b) "RESIDENCE" MEANS A SINGLE-FAMILY OWNER-OCCUPIED
27 DETACHED DWELLING.".
