

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

HB20-1324 be amended as follows:

1 Amend printed bill, page 2, after line 1 insert:

2 "SECTION 1. In Colorado Revised Statutes, **amend** 39-22-801  
3 as follows:

4 **39-22-801. Voluntary contribution designation - procedure.**  
5 For income tax years commencing on or after January 1, 2010, ~~but prior~~  
6 ~~to January 1, 2020~~, each Colorado state individual income tax return form  
7 ~~shall~~ MUST contain a line whereby each individual taxpayer may designate  
8 the amount of the contribution, if any, the taxpayer wishes to make to the  
9 Colorado domestic abuse program fund created in section 39-22-802."

10 Renumber succeeding sections accordingly.

11 Page 2, line 2, strike "**repeal**" and substitute "**amend**".

12 Page 2, strike lines 4 through 8 and substitute:

13 "**39-22-803. Repeal of part.** This part 8 is repealed, effective  
14 January 1 2021, ~~unless~~ OF THE INCOME TAX YEAR FOLLOWING THE YEAR  
15 IN WHICH THE EXECUTIVE DIRECTOR FILES WRITTEN CERTIFICATION WITH  
16 THE REVISOR OF STATUTES THAT the voluntary contribution to the  
17 Colorado domestic abuse program fund established in section 39-22-802  
18 ~~is continued or reestablished by the general assembly acting by bill prior~~  
19 ~~to said date~~ WILL NO LONGER APPEAR ON THE INDIVIDUAL INCOME TAX  
20 RETURN FORM DUE TO A FAILURE TO MEET STATUTORY REQUIREMENTS.

21 **SECTION 3.** In Colorado Revised Statutes, 39-22-1001, **amend**  
22 (1)(b) as follows:

23 **39-22-1001. Limitations on voluntary contribution programs**  
24 **- queue - notice - reestablishment of certain programs.** (1) (b) There  
25 shall be no requirement for a sunset clause for THE COLORADO DOMESTIC  
26 ABUSE PROGRAM FUND VOLUNTARY CONTRIBUTION ESTABLISHED IN PART  
27 8 OF THIS ARTICLE 22, the homeless prevention activities program fund  
28 voluntary contribution established in part 13 of this article 22, the western  
29 slope military veterans' cemetery voluntary contribution established in  
30 part 19 of this article 22, or the donate to a Colorado nonprofit fund  
31 voluntary contribution established in part 51 of this article 22. All other  
32 voluntary contribution programs shall remain on Colorado income tax  
33 returns for the income tax years specified in the part in which the  
34 voluntary contribution is established and shall be repealed or  
35 reestablished as directed in such part."
