Reduces the appropriation for Vehicle Replacement Lease/Purchase for the State Fleet Management and Motor Pool Services program in the Department of **Personnel** by \$5,061,397 reappropriated funds. Eliminates General Fund appropriations in **multiple departments** for vehicle lease payments for a total of \$5,061,397.
