  - 19 DISORDERS."

- 23 Renumber succeeding sections accordingly.

2 Page 53, strike lines 1 and 2.

3 Renumber succeeding sections accordingly.

4 Page 63, after line 25 insert:

5       **"SECTION 58. Appropriation.** For the 2020-21 state fiscal year,  
6 \$22,372 is appropriated to the department of regulatory agencies for use  
7 by the division of insurance. This appropriation is from the division of  
8 insurance cash fund created in section 10-1-103 (3), C.R.S., and is based  
9 on an assumption that the division will require an additional 0.3 FTE. To  
10 implement this act, the division may use this appropriation for personal  
11 services.

12       **SECTION 59. Applicability.** Section 1 of this act applies to  
13 health benefits plans issued or renewed on or after January 1, 2022."

14 Renumber succeeding section accordingly.

15 Page 1, line 101, strike "**DISORDERS.**" and substitute "**DISORDERS, AND,**  
16 **IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**".
