

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

SB20-057 be amended as follows:

1 Amend printed bill, page 3, after line 21 insert:

2 **"SECTION 3. Appropriation.** (1) For the 2020-21 state fiscal
3 year, \$977 is appropriated to the department of health care policy and
4 financing for use by the executive director's office. This appropriation is
5 from the general fund. To implement this act, the department may use this
6 appropriation for transfer to department of public health and environment
7 for facility survey and certification, which amount is subject to the "(M)"
8 notation as defined in the annual general appropriation act for the same
9 fiscal year.

10 (2) For the 2020-21 state fiscal year, the general assembly
11 anticipates that the department of health care and policy financing will
12 receive \$977 in federal funds to implement this act. The appropriation in
13 subsection (1) of this section is based on the assumption that the
14 department will receive this amount of federal funds to be used for
15 transfer to department of public health and environment for facility
16 survey and certification.

17 (3) For the 2020-21 state fiscal year, \$1,954 is appropriated to the
18 department of public health and environment for use by the health
19 facilities and emergency medical services division. This appropriation is
20 from reappropriated funds received from the department of health care
21 policy and financing under subsections (1) and (2) of this section. To
22 implement this act, the department may use this appropriation for transfer
23 to department of public safety.

24 (4) For the 2020-21 state fiscal year, the general assembly
25 anticipates that the department of public health and environment will
26 receive \$2,197 in federal funds for use by the health facilities and
27 emergency medical services division, which amount is included for
28 informational purposes only. The appropriation in subsection (3) of this
29 section is based on the assumption that the department will receive this
30 amount of federal funds to be used for transfer to department of public
31 safety.

32 (5) For the 2020-21 state fiscal year, \$4,151 is appropriated to the
33 department of public safety for use by the division of fire prevention and
34 control. This appropriation is from reappropriated funds received from
35 the department of public health and environment under subsections (3)
36 and (4) of this section. To implement this act, the division may use this
37 appropriation for personal services and wildland fire management
38 services.

39 (6) For the 2020-21 state fiscal year, \$22,598 is appropriated to the
40 department of public safety for use by the division of fire prevention and

1 control. This appropriation is from various cash funds, including: the
2 Firefighter, First Responder, Hazardous Materials Responder, and
3 Prescribed Fire Training and Certification Fund created in Section
4 24-33.5-1207 (1), C.R.S.; the Fire Suppression Cash Fund created in
5 Section 24-33.5-1207.6 (1), C.R.S.; the Fireworks Licensing Cash Fund
6 created in Section 24-33.5-2004 (6)(b), C.R.S.; the Fire Service Education
7 and Training Fund created in Section 24-33.5-1207.5 (1), C.R.S.; the
8 Health Facility Construction and Inspection Cash Fund created in Section
9 24-33.5-1207.8, C.R.S.; the Public School Construction and Inspection
10 Cash Fund created in Section 24-33.5-1207.7, C.R.S.; the Wildland-urban
11 Interface Training Fund created in Section 24-33.5-1212 (5)(a)(I), C.R.S.;
12 and from various other sources of cash funds including gifts and grants.
13 To implement this act, the division may use this appropriation for
14 personal services and wildland fire management services."

15 Renumber succeeding section accordingly.

16 Page 1, line 103 strike "**BENEFITS.**" and substitute "**BENEFITS, AND, IN**
17 **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**".
