## SENATE FLOOR AMENDMENT

Second Reading

BY SENATOR Holbert

1 Amend printed bill, page 2, lines 2 and 3, strike "(1), (3)(b), and (3)(c)"  
2 and substitute "(1) and (3)(b); **repeal** (3)(c); and **add** (3.5)".

3 Page 2, strike lines 20 through 22 and substitute "(3)(a)(I) AND (3)(a)(II)  
4 OF THIS SECTION."

5 Page 3, strike line 1.

6 Page 3, after line 5 insert:

7           "(c) FOR THE PURPOSES OF IMPOSING A FINE, THE STATE LICENSING  
8 AUTHORITY SHALL ADOPT RULES ESTABLISHING CATEGORIES OF  
9 VIOLATIONS BY LEVEL OF SEVERITY AND ASSOCIATED RANGES OF  
10 PENALTIES FOR STATE AND LOCAL LICENSING AUTHORITIES, INCLUDING  
11 AGGRAVATING AND MITIGATING FACTORS TO BE CONSIDERED IN  
12 DETERMINING PENALTIES. A FINE IMPOSED PURSUANT TO THIS SUBSECTION  
13 (1) MUST BE BETWEEN FIVE HUNDRED AND ONE HUNDRED THOUSAND  
14 DOLLARS; EXCEPT THAT PENALTIES FOR A FIRST VIOLATION THAT IS IN THE  
15 LEAST SEVERE LEVEL OF LICENSE VIOLATIONS ESTABLISHED PURSUANT TO  
16 THIS SUBSECTION (1)(c) MUST NOT EXCEED FIVE THOUSAND DOLLARS."

17 Page 3, line 7, strike "THIS SECTION OR".

18 Page 3, strike line 8.

19 Page 3, strike lines 13 through 19 and substitute:

20           "~~(c) Payment of any fine pursuant to the provisions of this~~  
21 ~~subsection (3) shall be in the form of cash or in the form of a certified~~  
22 ~~check or cashier's check made payable to the state or local licensing~~  
23 ~~authority, whichever is appropriate.~~

24           (3.5) THE METHOD OF PAYMENT OF ANY FINE PURSUANT TO  
25 SUBSECTION (1) OR (3) OF THIS SECTION:

26           (a) TO A LOCAL LICENSING AUTHORITY SHALL BE IN THE FORM OF  
27 CASH OR IN THE FORM OF A CERTIFIED CHECK OR CASHIER'S CHECK MADE  
28 PAYABLE TO THE LOCAL LICENSING AUTHORITY;

29           (b) TO THE STATE LICENSING AUTHORITY SHALL BE IN THE FORM  
30 DETERMINED BY THE STATE LICENSING AUTHORITY BY RULE."
