SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business, Labor, & Technology.

SB20-120 be amended as follows:

1 Amend printed bill, page 2, line 3, strike "and (5)" and substitute "(5), and  
2 (6)".

3 Page 2, line 5, strike "**discipline.**" and substitute "**discipline - repeal.**".

4 Page 3, after line 16 insert:

5 "(6) (a) THE DEPARTMENT OF REGULATORY AGENCIES, IN  
6 CONSULTATION WITH THE BOARD, INDUSTRY STAKEHOLDERS,  
7 EXAMINATION PROCTORS, NATIONAL CODE ORGANIZATIONS,  
8 APPRENTICESHIP TRAINING COORDINATORS, AND THE DEPARTMENT OF  
9 LABOR AND EMPLOYMENT SHALL CONDUCT RESEARCH TO DETERMINE  
10 WHAT BARRIERS EXIST IN THE PREPARATION AND TAKING OF THE  
11 EXAMINATION PROVIDED FOR IN SECTION 12-115-110 FOR APPRENTICES  
12 FOR WHOM ENGLISH IS A SECOND LANGUAGE AND, ON OR BEFORE  
13 JANUARY 1, 2021, SHALL REPORT ITS FINDINGS, INCLUDING ANY  
14 LEGISLATIVE OR REGULATORY RECOMMENDATIONS, TO THE GENERAL  
15 ASSEMBLY.

16 (b) THIS SUBSECTION (6) IS REPEALED, EFFECTIVE JULY 1, 2021."

17 Page 3, line 18, strike "and (5)" and substitute "(5), and (6)".

18 Page 3, line 19, strike "**Apprentices.**" and substitute "**Apprentices -  
19 repeal.**".

20 Page 4, after line 24 insert:

21 "(6) (a) THE DEPARTMENT OF REGULATORY AGENCIES, IN  
22 CONSULTATION WITH THE BOARD, INDUSTRY STAKEHOLDERS,  
23 EXAMINATION PROCTORS, NATIONAL CODE ORGANIZATIONS,  
24 APPRENTICESHIP TRAINING COORDINATORS, AND THE DEPARTMENT OF  
25 LABOR AND EMPLOYMENT SHALL CONDUCT RESEARCH TO DETERMINE  
26 WHAT BARRIERS EXIST IN THE PREPARATION AND TAKING OF THE  
27 EXAMINATION PROVIDED FOR IN SECTION 12-155-110 FOR PLUMBING  
28 APPRENTICES FOR WHOM ENGLISH IS A SECOND LANGUAGE AND, ON OR  
29 BEFORE JANUARY 1, 2021, SHALL REPORT ITS FINDINGS, INCLUDING ANY  
30 LEGISLATIVE OR REGULATORY RECOMMENDATIONS, TO THE GENERAL  
31 ASSEMBLY.

32 (b) THIS SUBSECTION (6) IS REPEALED, EFFECTIVE JULY 1, 2021."
