SB20-128 be amended as follows:

1 Amend printed bill, page 9, after line 11 insert:

"SECTION 4. In Colorado Revised Statutes, 40-15-604, amend (1) as follows:

- **40-15-604. Electric utility obligations.** (1) (a) An electric utility OR A GENERATION AND TRANSMISSION COOPERATIVE that exercises any rights under section 40-15-602 (1)(a) or (1)(b) for the provision of commercial broadband service shall:
- (a) (I) Not discriminate among commercial broadband suppliers, including broadband affiliates, THAT, AT THE TIME RIGHTS ARE BEING EXERCISED UNDER SECTIONS 40-15-602 (1)(a) OR (1)(b), OFFER BROADBAND SERVICE IN COLORADO, in offering or granting rights to install or attach any attached facilities; or
- (b) (II) Charge fees that are nondiscriminatory among commercial broadband suppliers THAT, AT THE TIME RIGHTS ARE BEING EXERCISED UNDER SECTIONS 40-15-602 (1)(a) OR (1)(b), OFFER BROADBAND SERVICE IN COLORADO, for a substantially similar lease or use of the capacity of attached facilities SOLELY owned or controlled by the electric utility OR GENERATION AND TRANSMISSION COOPERATIVE, but only to the extent an electric utility or generation and transmission cooperative that DIRECTLY EXERCISED ITS RIGHTS UNDER SECTION 40-15-602 (1)(b) chooses, in its sole discretion, to offer the lease or use to a particular commercial broadband supplier. IT IS NOT DISCRIMINATORY UNDER THIS SUBSECTION (1)(a) FOR AN ELECTRIC UTILITY OR GENERATION AND TRANSMISSION COOPERATIVE TO HAVE DIFFERENT FEES BASED UPON DIFFERENT ROUTES, DIFFERENT TERMS OF THE LEASE, OR DIFFERENT VOLTAGE OF ELECTRIC SERVICE INFRASTRUCTURE OR BASED ON THE AMOUNT OF EXCESS CAPACITY OF ATTACHED FACILITIES THAT IS STILL AVAILABLE; TO CHANGE ITS FEE OVER TIME; OR TO DETERMINE, IN ITS SOLE DISCRETION, THAT NO ADDITIONAL EXCESS CAPACITY IS AVAILABLE.
 - (b) Subsection (1)(a) of this section does not apply to contracts or agreements already in existence at the time of the effective date of this subsection (1)(b).".
