- 4 LOCAL PUBLIC HEALTH ORDER THAT HAS BEEN IN EFFECT SINCE DECEMBER
- 5 10, 2020, OR EARLIER AND THAT INCLUDES THE FOLLOWING".
- 6 Page 4, strike line 13 and substitute:
- 7 "(II) IN GOOD-FAITH COMPLIANCE WITH THE EXECUTIVE ORDERS

- 9 ALL APPLICABLE STATEWIDE AND LOCAL PUBLIC HEALTH ORDERS THAT".

- strike "RESTRICTIONS." and substitute "RESTRICTIONS, AS DETERMINED BY
- 12 THE DIVISION IN CONSULTATION WITH THE DEPARTMENT OF PUBLIC
- HEALTH AND ENVIRONMENT AND AS DEMONSTRATED BY:
- 14 (A) The county's good-faith efforts to enforce or
- 15 PROMOTE COMPLIANCE WITH APPLICABLE EXECUTIVE AND PUBLIC HEALTH
- 16 ORDERS WITHIN THE SCOPE OF ITS AUTHORITY AND IN CONSIDERATION OF
- 17 AVAILABLE RESOURCES, INCLUDING ENGAGING LAW ENFORCEMENT TO
- 18 ENFORCE EXECUTIVE AND PUBLIC HEALTH ORDER VIOLATIONS; AND
- 19 (B) THE COUNTY NOT ADOPTING A PUBLIC HEALTH ORDER OR
- 20 ENFORCEMENT POLICY THAT IS LESS RESTRICTIVE THAN A STATEWIDE
- 21 PUBLIC HEALTH ORDER ADOPTED BY THE DEPARTMENT OF PUBLIC HEALTH
- 22 AND ENVIRONMENT, UNLESS THE COUNTY HAS OBTAINED A VARIANCE OR
- 23 OTHER EXEMPTION FROM THE DEPARTMENT OF PUBLIC HEALTH AND
- 24 ENVIRONMENT.".
- Page 6, line 22, strike "ALL STATE" and substitute "THE EXECUTIVE
- 26 ORDERS PERTAINING TO THE PUBLIC HEALTH EMERGENCY DUE TO
- 27 COVID-19 AND ALL APPLICABLE STATEWIDE".
