SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

SB20B-001 be amended as follows:

1 Amend printed bill, page 9, line 7, after "ANY" insert "NEW OR".

2 Page 9, line 9, after "THROUGH" insert "INTERGOVERNMENTAL
3 AGREEMENTS WITH OTHER ELIGIBLE LOCAL GOVERNMENTS OR POLITICAL
4 SUBDIVISIONS AND", and after "WITH" insert "PUBLIC OR".

5 Page 9, line 10, strike "TO PROVIDE" and substitute "TO:

6 (A) PROVIDE".

7 Page 9, strike lines 12 through 22 and substitute "EXPEDITIOUS AND
8 EFFICIENT MANNER; AND

9 (B) ENCOURAGE AND FACILITATE THE EQUITABLE DISTRIBUTION
10 OF RELIEF PAYMENTS TO ELIGIBLE SMALL BUSINESSES WITHIN THE
11 MUNICIPALITIES AND POLITICAL SUBDIVISIONS LOCATED WITHIN THE
12 GEOGRAPHICAL BOUNDARIES OF THE ELIGIBLE LOCAL GOVERNMENT.

13 (II) EACH ELIGIBLE LOCAL GOVERNMENT THAT RECEIVES AN
14 ALLOCATION FROM THE DIVISION PURSUANT TO THE RELIEF PROGRAM
15 SHALL:

16 (A) ALLOW SMALL BUSINESSES LOCATED WITHIN THE
17 GEOGRAPHICAL BOUNDARIES OF THE ELIGIBLE LOCAL GOVERNMENT A
18 SPECIFIED PERIOD OF NOT LESS THAN TWENTY-ONE DAYS DURING WHICH
19 TO APPLY FOR RELIEF PAYMENTS;

20 (B) NOT DISTRIBUTE RELIEF PAYMENTS BASED ON THE ORDER IN
21 WHICH APPLICATIONS ARE SUBMITTED OR RECEIVED; AND

22 (C) COLLECT SUFFICIENT INFORMATION FROM SMALL BUSINESS
23 APPLICANTS TO ENABLE THE ELIGIBLE LOCAL GOVERNMENT TO ISSUE AN
24 INTERNAL REVENUE SERVICE FORM 1099 TO AN ELIGIBLE SMALL BUSINESS
25 THAT RECEIVES A RELIEF PAYMENT PURSUANT TO THIS SECTION.

26 (III) ELIGIBLE LOCAL GOVERNMENTS THAT APPLY TO PARTICIPATE
27 IN THE RELIEF PROGRAM MUST COMMUNICATE INFORMATION ABOUT THE
28 RELIEF PROGRAM IN A MANNER THAT INFORMS SMALL BUSINESSES
29 LOCATED WITHIN THE GEOGRAPHICAL BOUNDARIES OF THE ELIGIBLE
30 LOCAL GOVERNMENT ABOUT THE RELIEF PROGRAM AND HOW AND WHEN
31 TO APPLY FOR RELIEF PAYMENTS."

32 Page 9, line 26, after "GOVERNMENT" insert "BASED ON THE PAYMENT
33 AMOUNTS SPECIFIED IN SUBSECTION (2)(b)(II) OF THIS SECTION, REDUCED
34 AS NECESSARY BASED ON THE TOTAL AMOUNT ALLOCATED TO THE
35 ELIGIBLE LOCAL GOVERNMENT PURSUANT TO SUBSECTION (2)(a) OF THIS
36 SECTION,".
