Committee on Transportation & Local Government.

HB21-1014 be amended as follows:

- 1 Amend printed bill, page 3, line 26, strike "LICENSEE'S" and substitute
2 "FACT THAT THE LICENSEE HAS REQUESTED THAT A" and after "SYMBOL"
3 insert "BE".
- 4 Page 4, strike lines 10 through 13 and substitute "LICENSE IN
5 ACCORDANCE WITH THIS SUBSECTION (12) MUST BE DISCREET AND MUST
6 REPRESENT ALL TYPES OF DISABILITIES, INCLUDING COGNITIVE
7 DISABILITIES, NEUROLOGICAL DIVERSITIES, MENTAL HEALTH DISORDERS,
8 SENSORY NEEDS, CHRONIC ILLNESS, CHRONIC PAIN, AND PHYSICAL
9 DISABILITIES. THE DESIGN MUST CONFORM TO THE CURRENT STANDARDS
10 ADOPTED BY THE INVISIBLE DISABILITIES ASSOCIATION, INC., OR ITS
11 SUCCESSOR ORGANIZATION."
- 12 Page 5, line 6, strike "REGISTRANT'S" and substitute "FACT THAT THE
13 REGISTRANT HAS REQUESTED THAT A" and after "SYMBOL" insert "BE".
- 14 Page 5, strike lines 17 through 20 and substitute "IDENTIFICATION CARD
15 IN ACCORDANCE WITH THIS SUBSECTION (6) MUST BE DISCREET AND MUST
16 REPRESENT ALL TYPES OF DISABILITIES, INCLUDING COGNITIVE
17 DISABILITIES, NEUROLOGICAL DIVERSITIES, MENTAL HEALTH DISORDERS,
18 SENSORY NEEDS, CHRONIC ILLNESS, CHRONIC PAIN, AND PHYSICAL
19 DISABILITIES. THE DESIGN MUST CONFORM TO THE CURRENT STANDARDS
20 ADOPTED BY THE INVISIBLE DISABILITIES ASSOCIATION, INC., OR ITS
21 SUCCESSOR ORGANIZATION."
- 22 Page 5, line 26, strike "**amend (9)**" and substitute "**add (9.5)**".
- 23 Page 6, strike lines 1 through 12 and substitute:
24 "**42-3-113. Records of application and registration - disability**
25 **of a driver - definitions.** (9.5) (a) WHEN REGISTERING OR RENEWING THE
26 REGISTRATION OF A VEHICLE PURSUANT TO THIS SECTION, THE
27 DEPARTMENT SHALL COLLECT INFORMATION THAT THE".
- 28 Page 6, line 18, strike "(c)" and substitute "(b)".
- 29 Page 6, strike lines 20 through 23.
- 30 Page 6, strike lines 25 and 26 and substitute "takes effect July 1, 2022;
31 except".
