SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

HB21-1014 be amended as follows:

1 Amend reengrossed bill, page 4, line 15, after "REQUEST," insert "AND  
2 UPON COMPLETION OF THE APPLICATION PURSUANT TO SECTION  
3 (12)(a)(II)(A) OF THIS SECTION,".

4 Page 4, strike lines 21 through 24 and substitute:

5           "(II) (A) THE DEPARTMENT SHALL PROMULGATE A RULE CREATING  
6 AN APPLICATION AND RENEWAL FORM THAT IS SIGNED BY A PROFESSIONAL,  
7 UNDER PENALTY OF PERJURY, TO AFFIRM THAT AN APPLICANT MEETS THE  
8 ELIGIBILITY REQUIREMENTS FOR A DISABILITY IDENTIFIER SYMBOL AND  
9 SETTING OUT THE PENALTIES FOR AUTHORIZING A DISABILITY IDENTIFIER  
10 SYMBOL BEFORE VERIFYING THAT THE APPLICANT HAS A DISABILITY THAT  
11 INTERFERES WITH THE APPLICANT'S ABILITY TO EFFECTIVELY  
12 COMMUNICATE WITH A PEACE OFFICER.

13           (B) AS USED IN THIS SUBSECTION (12)(a)(II), "PROFESSIONAL"  
14 MEANS A PHYSICIAN LICENSED TO PRACTICE MEDICINE UNDER ARTICLE 240  
15 OF THIS TITLE 12 OR PRACTICING MEDICINE UNDER SECTION 12-240-107  
16 (3)(i), A PHYSICIAN ASSISTANT LICENSED UNDER SECTION 12-240-113, A  
17 MENTAL HEALTH PROFESSIONAL LICENSED OR CERTIFIED PURSUANT TO  
18 ARTICLE 245 OF TITLE 12, AN ADVANCED PRACTICE NURSE REGISTERED  
19 UNDER SECTION 12-255-111, A PERSON WITH A MASTER'S DEGREE IN  
20 REHABILITATION COUNSELING, OR A PHYSICIAN, PHYSICIAN ASSISTANT,  
21 MENTAL HEALTH PROFESSIONAL, OR ADVANCED PRACTICE REGISTERED  
22 NURSE AUTHORIZED TO PRACTICE PROFESSIONALLY BY ANOTHER STATE  
23 THAT SHARES A COMMON BORDER WITH COLORADO."
