1 Amend the State, Civic, Military, & Veterans Affairs Committee Report,
2 dated March 4, 2021, page 1, after line 14 insert:

4 "(a) "ADVISORY COMMITTEE" MEANS A GROUP OF PERSONS WHO
5 ARE NOT NONPARTISAN STAFF OF THE COUNTY WHO ARE ASSIGNED TO
6 ASSIST THE COMMISSION BY THE BOARD OF COUNTY COMMISSIONERS. THE
7 BOARD OF COUNTY COMMISSIONERS MAY DELEGATE ANY FUNCTIONS BUT
8 THE FINAL ADOPTION OF A PLAN TO THE ADVISORY COMMITTEE. THE
9 ADVISORY COMMITTEE MUST BE COMPOSED OF AN EQUAL NUMBER OF
10 MEMBERS WHO ARE AFFILIATED WITH THE STATE'S LARGEST POLITICAL
11 PARTY, AFFILIATED WITH THE STATE'S SECOND LARGEST POLITICAL PARTY,
12 AND NOT AFFILIATED WITH ANY POLITICAL PARTY. FOR PURPOSES OF THIS
13 SUBSECTION (6)(a), THE STATE'S TWO LARGEST POLITICAL PARTIES SHALL
14 BE DETERMINED BY THE NUMBER OF REGISTERED ELECTORS AFFILIATED
15 WITH EACH POLITICAL PARTY IN THE STATE ACCORDING TO VOTER
16 REGISTRATION DATA PUBLISHED BY THE SECRETARY OF STATE FOR THE
17 EARLIEST DAY IN JANUARY OF THE REDISTRICTING YEAR FOR WHICH SUCH
18 DATA IS PUBLISHED."

8 WITH ANYONE, INCLUDING STAFF, EXCEPT OTHER MEMBERS OF THE
9 ADVISORY COMMITTEE. COMMUNICATIONS ABOUT THE CONTENT OR
10 DEVELOPMENT OF ANY PLAN INCLUDE COMMUNICATIONS ABOUT HOW
11 PLANS WILL BE DRAWN TO SATISFY THE CRITERIA IN SECTION 30-10-306.3,
12 SPECIFIC PARAMETERS RELATED TO THE INTERPRETATION OF THE CRITERIA
13 IN SECTION 30-10-306.3, AND REQUESTS FOR THE DRAWING OF
14 ADDITIONAL PLANS." and after "STAFF" insert "OR MEMBERS OF THE
15 ADVISORY COMMITTEE".
