

HB21-1159 be amended as follows:

1 Amend printed bill, page 4, after line 4 insert:

2 "SECTION 5. In Colorado Revised Statutes, 44-10-601, amend  
3 (13)(f)(VII) as follows:

4 **44-10-601. Retail marijuana store license - rules - definitions.**

5 (13) (f) In accordance with this subsection (13) and rules adopted to  
6 implement this subsection (13), a licensed retail marijuana store with a  
7 valid retail marijuana delivery permit may:

8 (VII) (A) Use an employee to conduct deliveries or contract with  
9 a retail marijuana transporter that has a valid retail marijuana delivery  
10 permit to conduct deliveries on its behalf, from its retail marijuana store  
11 or its associated state licensing authority-authorized storage facility as  
12 defined by rule.

13 (B) IF A LICENSED RETAIL MARIJUANA STORE CONTRACTS WITH A  
14 RETAIL MARIJUANA TRANSPORTER TO CONDUCT THE DELIVERIES FOR THE  
15 STORE AND THE STATE LICENSING AUTHORITY FINDS THE TRANSPORTER  
16 VIOLATED THIS ARTICLE 10, OR ANY RULE PROMULGATED PURSUANT TO  
17 THIS ARTICLE 10, WHEN THE VIOLATION IS RELATED TO DELIVERY AND THE  
18 STATE LICENSING AUTHORITY DEEMS IT TO BE A VIOLATION OF PUBLIC  
19 SAFETY, THE STATE LICENSING AUTHORITY SHALL NOTIFY THE STORE OF  
20 THE VIOLATION. A VIOLATION AFFECTING PUBLIC SAFETY INCLUDES THE  
21 TRANSFER OF REGULATED MARIJUANA TO A PERSON UNDER TWENTY-ONE  
22 YEARS OF AGE, THE TRANSFER OF REGULATED MARIJUANA IN EXCESS OF  
23 SALES LIMITATIONS, AND THE DIVERSION OF REGULATED MARIJUANA.

24 (C) IF THE STORE CONTINUES TO CONTRACT WITH THE RETAIL  
25 MARIJUANA TRANSPORTER TO CONDUCT THE STORE'S DELIVERIES AND THE  
26 STATE LICENSING AUTHORITY FINDS THE TRANSPORTER COMMITTED A  
27 SECOND OR SUBSEQUENT VIOLATION OF THIS ARTICLE 10, OR ANY RULE  
28 PROMULGATED PURSUANT TO THIS ARTICLE 10, WHEN THE VIOLATION IS  
29 RELATED TO DELIVERY, IS DEEMED A VIOLATION AFFECTING PUBLIC  
30 SAFETY, AND OCCURS WITHIN A YEAR OF THE FINAL AGENCY ACTION  
31 VIOLATION OF A PREVIOUS VIOLATION, THE STATE LICENSING AUTHORITY  
32 SHALL INITIATE ADMINISTRATIVE ACTION AGAINST THE RETAIL MARIJUANA  
33 STORE IN ADDITION TO ANY DISCIPLINARY ADMINISTRATIVE ACTION  
34 AGAINST THE RETAIL MARIJUANA TRANSPORTER.

35 (D) NOTHING IN THIS SUBSECTION (13)(f)(VII) LIMITS THE  
36 AUTHORITY OF THE STATE LICENSING AUTHORITY TO IMPOSE DISCIPLINARY  
37 ADMINISTRATIVE ACTION AGAINST A RETAIL MARIJUANA TRANSPORTER OR  
38 MEDICAL MARIJUANA TRANSPORTER FOR VIOLATIONS OF STATE LAW OR  
39 RULE."
