SENATE FLOOR AMENDMENT

Second Reading

BY SENATOR Smallwood

1 Amend reengrossed bill, page 21, line 21, strike "HOSPITAL OR" and
2 substitute "HOSPITAL, A HEALTH SYSTEM, OR".

3 Page 21, strike line 22 and substitute "SHALL NOT:
4 (a) BALANCE BILL CONSUMERS ENROLLED IN THE STANDARDIZED".

5 Page 21, line 26, strike "CONSUMER." and substitute "CONSUMER;".

6 Page 21, after line 26 insert:

7 "(b) IN CONNECTION WITH THE STANDARDIZED PLAN, DEMAND AN
8 ANNUAL INCREASE IN THE REIMBURSEMENT RATES IN EXCESS OF MEDICAL
9 INFLATION FROM THE CURRENT RATE THE HOSPITAL, HEALTH SYSTEM, OR
10 HEALTH-CARE PROVIDER HAS NEGOTIATED WITH THE CARRIER, EVEN IF
11 THE CURRENT RATE IS BELOW THE REIMBURSEMENT RATES ESTABLISHED
12 PURSUANT TO SUBSECTION (4) OF THIS SECTION;

13 (c) DEMAND, OR RAISE AT ANY POINT IN NEGOTIATIONS WITH A
14 CARRIER, THAT THE RATE THE HOSPITAL, HEALTH SYSTEM, OR
15 HEALTH-CARE PROVIDER OFFERS THE CARRIER FOR ANY
16 NONSTANDARDIZED PLAN INCLUDE AN OFFSET OR OTHERWISE BE
17 INCREASED IN CONSIDERATION, IN WHOLE OR IN PART, OF THE REDUCTION
18 IN RATE OR OTHER FINANCIAL IMPACTS IT ASSOCIATES WITH THE
19 STANDARDIZED PLAN; OR

20 (d) DEMAND, OR RAISE AT ANY POINT IN NEGOTIATIONS WITH A
21 CARRIER, THAT THE RATE THE HOSPITAL, HEALTH SYSTEM, OR
22 HEALTH-CARE PROVIDER OFFERS THE CARRIER FOR ANY PROVIDER
23 LOCATION, HOSPITAL, OR HEALTH-CARE PROVIDER UNDER ITS COMMON
24 CONTROL IN COLORADO INCLUDE AN OFFSET OR OTHERWISE BE INCREASED
25 IN CONSIDERATION, IN WHOLE OR IN PART, OF THE REDUCTION IN RATE OR
26 OTHER FINANCIAL IMPACTS EXPERIENCED OR EXPECTED AT ANY OTHER
27 LOCATION, HOSPITAL, OR HEALTH-CARE PROVIDER UNDER ITS COMMON
28 CONTROL AS A RESULT OF, OR IN CONNECTION WITH, THE STANDARDIZED
29 PLAN."
